## AN ACT

1 Amending Title 34 (Game) of the Pennsylvania Consolidated  
2 Statutes, ~~further providing for powers and duties of the~~ <—  
3 ~~Pennsylvania Game Commission.~~ PROVIDING FOR USE OF CREDIT AND <—  
4 DEBIT CARDS.

5 The General Assembly of the Commonwealth of Pennsylvania  
6 hereby enacts as follows:

7 ~~Section 1. Section 322(c) of Title 34 of the Pennsylvania~~ <—  
8 ~~Consolidated Statutes is amended by adding a paragraph to read:~~  
9 ~~§ 322. Powers and duties of commission.~~

11 ~~(c) Specific powers and duties. In order to administrate~~  
12 ~~and enforce this title, the commission through proper action~~

15 ~~(11.1) By regulation, provide for the use of credit~~

5 SECTION 1. TITLE 34 OF THE PENNSYLVANIA CONSOLIDATED  
6 STATUTES IS AMENDED BY ADDING A SECTION TO READ:

7 § 326. USE OF CREDIT AND DEBIT CARDS.

8 (A) SALES OF LICENSES AND OTHER ITEMS.--THE EXECUTIVE  
9 DIRECTOR WITH THE APPROVAL OF THE COMMISSION MAY ESTABLISH  
10 POLICIES AND PROCEDURES FOR THE USE OF CREDIT CARDS AND DEBIT  
11 CARDS FOR THE PURCHASE OF LICENSES, PERMITS, PUBLICATIONS,  
12 PROMOTIONAL ITEMS AND OTHER ITEMS SOLD OR OFFERED FOR SALE BY  
13 THE COMMISSION.

14 (B) FINES AND SETTLEMENTS.--THE EXECUTIVE DIRECTOR WITH THE  
15 APPROVAL OF THE COMMISSION MAY ESTABLISH POLICIES AND PROCEDURES  
16 FOR USE OF DEBIT CARDS FOR PERSONS TO PAY FINES, SETTLEMENTS OR  
17 OTHER AMOUNTS COLLECTED UNDER THIS TITLE.

18 Section 2. This act shall take effect in ~~120~~ 90 days.
