## AN ACT

- Amending the act of December 14, 1988 (P.L.1192, No.147), entitled "An act requiring municipal retirement systems to 3 pay special ad hoc postretirement adjustments to certain retired police officers and firefighters; providing for the 5 financing of these adjustments; providing for the administration of the Commonwealth's reimbursements for these 7 adjustments; and making repeals," extending the provisions of the act to include survivors of police officers and 9 firefighters. The General Assembly of the Commonwealth of Pennsylvania

- 11 hereby enacts as follows:
- 12 Section 1. Section 102 of the act of December 14, 1988
- (P.L.1192, No.147), known as the Special Ad Hoc Municipal Police 13
- 14 and Firefighter Postretirement Adjustment Act, is amended by
- adding a definition to read:
- Section 102. Definitions. 16
- 17 The following words and phrases when used in this act shall
- have the meanings given to them in this section unless the 18
- context clearly indicates otherwise: 19
- 20

- 1 "Survivor." A person who is a widowed spouse of a police
- 2 <u>officer or firefighter and who is receiving survivor benefits</u>
- 3 <u>from a public employee retirement system.</u>
- 4 Section 2. Sections 301, 302 and 702 of the act are amended
- 5 to read:
- 6 Section 301. Entitlement to special ad hoc adjustment.
- 7 A municipal retirement system shall pay a retired police
- 8 officer or firefighter or the survivor of a deceased police
- 9 officer or firefighter a special ad hoc municipal police and
- 10 firefighter postretirement adjustment under this chapter if all
- 11 of the following apply:
- 12 (1) [The retiree has terminated active] Active
- 13 employment with the municipality as a police officer or
- 14 firefighter has terminated by reason of retirement or death.
- 15 (2) The retiree <u>or survivor</u> is receiving a retirement
- annuity, retirement benefit, service pension, survivor
- 17 <u>benefit</u> or disability pension benefit from a municipal
- 18 retirement system on the basis of active employment with a
- 19 municipality as a police officer or firefighter.
- 20 (3) The retiree or survivor began receiving the
- 21 retirement annuity, retirement benefit, service pension,
- 22 <u>survivor benefit</u> or disability pension benefit before January
- 23 1, 1985.
- 24 Section 302. Amount of special ad hoc adjustment.
- 25 (a) General rule. -- Except as provided in subsections [(b)
- 26 and] (c) and (d), a municipal retirement system shall pay a
- 27 retired police officer or firefighter or their survivors a
- 28 special ad hoc municipal police and firefighter postretirement
- 29 adjustment under section 301, as follows:
- 30 (1) The sum of \$25 a month, if on January 1, 1989, the

- 1 retiree has been retired at least five years but less than
- 2 ten years.
- 3 (2) The sum of \$50 a month, if on January 1, 1989, the
- 4 retiree is totally disabled and has been retired less than
- 5 ten years.
- 6 (3) The sum of \$75 a month, if on January 1, 1989, the
- 7 retiree has been retired at least ten years but less than 20
- 8 years.
- 9 (4) The sum of \$150 a month, if on January 1, 1989, the
- 10 retiree has been retired at least 20 years.
- 11 (b) Retirement date. -- In the case of a special ad hoc
- 12 postretirement adjustment payable to a survivor, the benefit
- 13 amounts shall be based on the date upon which the survivor began
- 14 receiving survivor benefits of the retiree.
- [(b)] (c) Limitation.--If, under section 301, a retiree or
- 16 survivor is entitled to be paid a special ad hoc municipal
- 17 police and firefighter postretirement adjustment by more than
- 18 one municipal retirement system, the amount of the special ad
- 19 hoc adjustment under subsection (a) shall be reduced so that the
- 20 total of all these adjustments paid to the retiree or survivor
- 21 does not exceed the amount specified in subsection (a).
- 22 [(c)] (d) Modification in amount of postretirement
- 23 adjustment.--If a retiree or survivor entitled to receive a
- 24 special ad hoc municipal police and firefighters postretirement
- 25 adjustment will receive a postretirement adjustment from the
- 26 applicable municipal police or paid firefighters pension plan
- 27 after the effective date of this act, the amount of the special
- 28 ad hoc postretirement adjustment under subsection (a) shall be
- 29 reduced by the total amount of any municipal postretirement
- 30 adjustment.

- 1 [(d)] (e) Construction. -- Subsections [(b) and (c)] (c) and
- 2 (d) shall not be construed to reduce the amount of any
- 3 retirement annuity, retirement benefit, service pension [or],
- 4 disability pension benefit or survivor benefit payable to a
- 5 retiree or survivor immediately prior to the effective date of
- 6 this act.
- 7 Section 702. Deposits into special account.
- 8 Notwithstanding any applicable provision of the act of May
- 9 12, 1943 (P.L.259, No.120), referred to as the Foreign Casualty
- 10 Insurance Premium Tax Allocation Law, or any applicable
- 11 provisions of the act of March 4, 1971 (P.L.6, No.2), known as
- 12 the Tax Reform Code of 1971, or the provisions of sections
- 13 402(b) and 803(c) of the act of December 18, 1984 (P.L.1005,
- 14 No.205), known as the Municipal Pension Plan Funding Standard
- 15 and Recovery Act, beginning on January 1, 1990, prior to the
- 16 deposit of the proceeds of the insurance premium tax on foreign
- 17 casualty insurance premiums into the General Municipal Pension
- 18 System State Aid Program revenue account, an amount sufficient
- 19 to provide for the Commonwealth's reimbursement payments to
- 20 municipalities for special ad hoc adjustments [under this act]
- 21 provided to retirees under section 302 shall be deposited in the
- 22 separate account created under section 701.
- 23 Section 3. The act is amended by adding a section to read:
- 24 <u>Section 703.</u> <u>Supplement from General Fund.</u>
- 25 <u>(a) Reimbursement amount.--An amount sufficient to reimburse</u>
- 26 <u>municipalities for special ad hoc adjustments provided to</u>
- 27 survivors under section 302 in the first year shall be paid from
- 28 the General Fund.
- 29 (b) Supplemental amounts.--Should the amount required to
- 30 reimburse municipalities for special ad hoc adjustments to

- 1 retirees under section 302 decrease after the first year, an
- 2 amount equal to the decrease shall be deposited in the separate
- 3 account created under section 701 and shall be used to reimburse
- 4 <u>municipalities for special ad hoc adjustments provided to</u>
- 5 <u>survivors under section 302</u>. If the amount of this deposit is
- 6 not sufficient to reimburse municipalities for provision of
- 7 <u>adjustments to survivors under section 302, the difference</u>
- 8 between the amount of this deposit and the amount required shall
- 9 <u>be paid from the General Fund.</u>
- 10 Section 4. Sections 901(a) and 902(a) of the act are amended
- 11 to read:
- 12 Section 901. Municipal retirement system certification of
- adjustments paid.
- 14 (a) Certification.--Beginning January 1, 1989, the chief
- 15 administrative officer of a municipal retirement system that
- 16 pays a special ad hoc adjustment [in that year] shall certify
- 17 the total of all adjustments paid during [that] each year to the
- 18 Auditor General not later than April 1 of the following year.
- 19 The adjustments paid to retirees and survivors under section 302
- 20 <u>shall be certified separately.</u>
- 21 \* \* \*
- 22 Section 902. Commonwealth disbursement of reimbursement
- payment.
- 24 (a) Payment to account. -- Not later than June 1 of the year
- 25 in which the form is due, the Auditor General shall certify to
- 26 the State Treasurer the amount to be deposited into the special
- 27 account created in section 701 and the amount to be paid from
- 28 the General Fund and shall draw a warrant, payable to the
- 29 treasurer of the municipality, on the State Treasurer from the
- 30 special account created in section 701 for the amount certified

- 1 under section 901(a).

- 3 Section 5. The provisions of this act are severable. If any
- 4 provision of this act or its application to any person or
- 5 circumstance is held invalid, the invalidity shall not affect
- 6 other provisions or applications of this act which can be given
- 7 effect without the invalid provision or application.
- 8 Section 6. This act shall take effect immediately.
