## AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- schools; amending, revising, consolidating and changing the
- laws relating thereto," further providing for payments for
- 6 pupil transportation.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 2541(c)(1) of the act of March 10, 1949
- 10 (P.L.30, No.14), known as the Public School Code of 1949,
- 11 amended November 20, 1979 (P.L.465, No.97), are amended and the
- 12 subsection is amended by adding a paragraph to read:
- 13 Section 2541. Payments on Account of Pupil Transportation. --
- 14 \* \* \*
- 15 (c) Payments for pupil transportation on account of the
- 16 school year [1979-1980] 1996-1997 and every school year
- 17 thereafter shall be made only in the following cases:

- 1 (1) To all school districts for the transportation to and
- 2 from school of elementary school pupils[, including kindergarten
- 3 pupils] from the fourth through the sixth grade, residing one
- 4 and one-half (1 1/2) miles or more by the nearest public highway
- 5 from the school in which the pupils are enrolled and to which
- 6 transportation is authorized under section 1361 of this act or
- 7 residing in areas where the road or traffic conditions are such
- 8 that walking constitutes a hazard to the safety of the child
- 9 when so certified by the Department of Transportation. The
- 10 Department of Transportation shall take into account the
- 11 presence of sidewalks along the highway, but such presence or
- 12 lack thereof shall not be controlling and the department shall
- 13 consider all relevant safety factors in making its determination
- 14 as to whether or not walking constitutes a hazard to pupils.
- 15 Such elementary school pupils shall include nonresident children
- 16 who are placed in the home of a resident, or who are residents
- 17 of an orphanage, or home or children's home or other institution
- 18 for the care and training of orphans or other children.
- 19 (1.1) To all school districts for the transportation to and
- 20 from school of pupils kindergarten through third grade,
- 21 regardless of distance of residence.

- 23 Section 2. This act shall take effect immediately.
