HOPKINS MEMORIAL HIGHWAY; AND DESIGNATING A CERTAIN BRIDGE IN THE BOROUGH OF CLARKS SUMMIT, LACKAWANNA COUNTY, AS THE VETERANS OF FOREIGN WARS MEMORIAL BRIDGE.	<—

15	Section 1. Bridge designation BARRY A. KING MEMORIAL BRIDGE.	<
16	(A) The bridge over the West Branch of the Susquehanna River	<
17	which carries SR 0011 from Point Township, Northumberland County	
18	to Monroe Township, Snyder County, is hereby designated and	
19	shall be known as the Barry A. King Memorial Bridge.

21	(B) The Department of Transportation shall erect and	<

- 4 (A) THE PULLMAN VIADUCT (SR 3001) IN BUTLER TOWNSHIP, BUTLER

- 5 COUNTY, WHICH CROSSES OVER SEVERAL RAILWAY TRACKS OF THE
- 6 BESSEMER AND LAKE ERIE RAILROAD OR OF ANY SUCCESSOR, IS HEREBY
- 7 REDESIGNATED AND SHALL BE KNOWN AS THE PICKLEGATE CROSSING.
- 8 (B) THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 9 MAINTAIN APPROPRIATE MARKERS OR SIGNS TO INDICATE THE
- 10 REDESIGNATION UNDER SUBSECTION (A).
- 11 SECTION 3. MIFFLIN-SOUTH CENTRE VETERANS MEMORIAL BRIDGE.
- 12 (A) THE BRIDGE LOCATED ON SR 2028 AT STATION 17+27.1 IN
- 13 MIFFLIN TOWNSHIP AND AT STATION 34+17.96 IN SOUTH CENTRE
- 14 TOWNSHIP, COLUMBIA COUNTY, IS HEREBY DESIGNATED AND SHALL BE
- 15 KNOWN AS THE MIFFLIN-SOUTH CENTRE VETERANS MEMORIAL BRIDGE.
- 16 (B) THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 17 MAINTAIN SIGNS WHICH SHALL DISPLAY THE NAME OF THE MIFFLIN-SOUTH
- 18 CENTRE VETERANS MEMORIAL BRIDGE SO DESIGNATED IN SUBSECTION (A).
- 19 SECTION 4. FOREST W. HOPKINS MEMORIAL HIGHWAY.
- 20 (A) THE EIGHT-MILE SEGMENT OF ROUTE 17 IN ERIE COUNTY, FROM
- 21 GREENFIELD TOWNSHIP TO THE NEW YORK STATE LINE, IS HEREBY
- 22 DESIGNATED AND SHALL BE KNOWN AS THE FOREST W. HOPKINS MEMORIAL
- 23 HIGHWAY.
- 24 (B) FOREST W. HOPKINS WAS A COMMITTED COMMUNITY SERVANT, WHO
- 25 SERVED WITH DISTINCTION AS A STATE REPRESENTATIVE FROM THE
- 26 FOURTH LEGISLATIVE DISTRICT FROM 1967 TO 1978. MR. HOPKINS DIED
- 27 IN OFFICE IN 1978.
- 28 (C) WITHIN 60 DAYS OF COMPLETION OF CONSTRUCTION OF THE
- 29 HIGHWAY SEGMENT DESCRIBED IN SUBSECTION (A), THE DEPARTMENT OF
- 30 TRANSPORTATION SHALL ERECT AND MAINTAIN ROAD SIGNS DISPLAYING

- 1 THE DESIGNATION "FOREST W. HOPKINS MEMORIAL HIGHWAY," AT THE
- 2 BEGINNING AND END OF THE HIGHWAY SEGMENT.
- 3 SECTION 5. VETERANS OF FOREIGN WARS MEMORIAL BRIDGE.
- 4 (A) THE BRIDGE CARRYING WINOLA ROAD (SR 4024) OVER RAILROAD
- 5 TRACKS, SITUATED IN THE BOROUGH OF CLARKS SUMMIT, LACKAWANNA
- 6 COUNTY, SHALL HEREAFTER BE KNOWN AS THE VETERANS OF FOREIGN WARS
- 7 MEMORIAL BRIDGE.
- 8 (B) THE DEPARTMENT OF TRANSPORTATION SHALL ERECT APPROPRIATE
