AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, further providing for attainment of
- 3 full age.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 5101 of Title 23 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 5101. Attainment of full age.
- 9 (a) Age for entering into contracts.--Any individual 18
- 10 years of age and older shall have the right to enter into
- 11 binding and legally enforceable contracts and the defense of
- 12 minority shall not be available to such individuals.
- 13 (b) Age for suing and being sued.--Except where otherwise
- 14 provided or prescribed by law, an individual 18 years of age and
- 15 older shall be deemed an adult and may sue and be sued as such.
- 16 (c) Security. -- An individual 18 years of age or older shall

- 1 have the capacity to transfer or purchase a security, to receive
- 2 <u>or empower others to receive dividends, interest, principal or</u>
- 3 other payments or distributions, to vote to give consent in
- 4 person or by proxy, or to make elections or exercise rights
- 5 relating to the security. The defense of minority shall not be
- 6 available to these individuals.
- 7 (d) Definitions.--As used in this section, the term
- 8 <u>"security" shall mean any note, stock, treasury stock, bond,</u>
- 9 <u>debenture</u>, <u>evidence</u> of <u>indebtedness</u>, <u>certificate</u> of <u>interest</u> of
- 10 participation in an oil, gas or mining title or lease, or in
- 11 payment out of production under such a title or lease,
- 12 <u>collateral trust certificate, transferable share, voting trust</u>
- 13 certificate or, in general, any interest or instrument commonly
- 14 known as a security, or any certificate or interest or
- 15 participation in, any temporary or interim certificate, receipt
- 16 or certificate of deposit for, or any warrant or right to
- 17 <u>subscribe to or purchase any of the foregoing.</u>
- 18 Section 2. This act shall take effect in 60 days.
