## AN ACT

Amending Title 18 (Crimes and Offenses) of the Pennsylvania 1 Consolidated Statutes, further providing for offense of 2 3 scattering rubbish. 4 The General Assembly of the Commonwealth of Pennsylvania 5 hereby enacts as follows: Section 1. Section 6501(a)(3) and (b)(5) of Title 18 of the 6 Pennsylvania Consolidated Statutes are amended to read: 8 § 6501. Scattering rubbish. 9 (a) Offense defined. -- A person is guilty of an offense if 10 he: 11 12 (3) is the owner or operator, or an agent of either, of 13 [a trash, garbage or debris collection vehicle, including

private automobiles and small trucks, or any other type of

vehicles] any vehicle used [to collect or transport] AT ANY
