## AN ACT

- 1 Authorizing and directing the Department of General Services,
- with the approval of the Governor, to convey a tract of land
- 3 located in Somerset Township, Somerset County, Pennsylvania.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. The Department of General Services, with the
- 7 approval of the Governor, is hereby authorized and directed, on
- 8 behalf of the Commonwealth of Pennsylvania, to grant and convey,
- 9 Somerset Christian Fellowship, the described tract of land in
- 10 section 2 for fair market value as determined by an independent
- 11 appraisal.
- 12 Section 2. Beginning at an existing iron pin/cap and on the
- 13 jurisdictional division line between lands of the Somerset
- 14 Christian Fellowship and lands of the Commonwealth of
- 15 Pennsylvania. Thence along lands of the Commonwealth of
- 16 Pennsylvania and the Somerset Christian Fellowship the following
- 17 courses and distances;
- 18 1. South 65 degrees 43 minutes 09 seconds East, 403.22 feet

- 1 to set iron pin/cap;
- 2 2. North 39 degrees 36 minutes 00 seconds East, 238.77 feet
- 3 to set iron pin/cap;
- 4 3. South 22 degrees 49 minutes 30 seconds West, 32.30 feet
- 5 to set iron pin/cap;
- 6 4. South 38 degrees 46 minutes 00 seconds West, 139.80 feet
- 7 to set iron pin/cap;
- 8 5. South 66 degrees 05 minutes 15 seconds East, 49.00 feet
- 9 to set iron pin/cap;
- 10 6. South 20 degrees 05 minutes 15 seconds West, 145.67 feet
- 11 to set iron pin/cap;
- 7. North 65 degrees 21 minutes 15 seconds West, 370.50 feet
- 13 to set iron pin/cap;
- 8. North 32 degrees 20 minutes 00 seconds West, 145.30 feet
- 15 to set iron pin/cap;
- 16 Containing approximately .936 acres.
- 17 Section 3. The conveyance shall be made under and subject to
- 18 all easements, servitudes and rights of others, including, but
- 19 not confined to, streets, roadways and rights of telephone,
- 20 telegraph, water, electric, sewer, gas or pipeline companies, as
- 21 well as under and subject to any interests, estates or tenancies
- 22 vested in third persons, whether or not appearing of record, for
- 23 any portion of the land or improvements erected thereon.
- 24 Section 4. The deed of conveyance shall be approved as
- 25 provided by law and shall be executed by the Secretary of
- 26 General Services in the name of the Commonwealth of
- 27 Pennsylvania.
- 28 Section 5. The cost and fees incidental to this conveyance
- 29 shall be borne by the grantee.
- 30 Section 6. This act shall take effect immediately.
