AN ACT

Amending the act of July 15, 1976 (P.L.1036, No.208), entitled, as amended, "An act authorizing the indebtedness, with the 3 approval of the electors, of fifty million dollars for loans to volunteer fire companies, volunteer ambulance services and 5 volunteer rescue squads for the purpose of establishing or modernizing facilities to house fire fighting apparatus 7 equipment, ambulances, and rescue vehicles, and for purchasing new fire fighting apparatus equipment, ambulances, and rescue vehicles, protective and communications equipment, 9 and any other accessory equipment necessary for the proper 10 11 performance of such organizations' duties, " adding a 12 definition. 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. Section 3 of the act of July 15, 1976 (P.L.1036, 16 No.208), known as the Volunteer Fire Company, Ambulance Service 17 and Rescue Squad Assistance Act, is amended by adding a definition to read: 18 19 Section 3. Definitions. -- As used in this act: 20 21 "National Fire Protection Association (NFPA) Standards" means

- 1 apparatus and equipment, including personal protective
- 2 equipment, shall be deemed to meet the requirements of
- 3 <u>compliance with the applicable standards of the National Fire</u>
- 4 Protection Association (NFPA) provided:
- 5 (1) New apparatus shall be constructed to meet or exceed the
- 6 standards in effect at the time of manufacture.
- 7 (2) Used firefighting apparatus shall:
- 8 (i) in no instance, meet lesser requirements than the
- 9 standards for apparatus adopted by the National Fire Protection
- 10 Association in 1991; and
- 11 (ii) beginning with the effective date of this amendatory
- 12 act, meet the National Fire Protection Association standards for
- 13 apparatus in effect at the time of original manufacture:
- 14 Provided, however, that no loans shall be considered or made for
- 15 <u>apparatus that cannot meet the National Fire Protection</u>
- 16 Association standards in effect within 12 years of the date of
- 17 the application for loan financing.
- 18 (3) New equipment shall meet or exceed the standards in
- 19 effect at the time of original manufacture.
- 20 (4) Used equipment shall meet or exceed the standards in
- 21 <u>effect at the time of original manufacture, however, no loans</u>
- 22 for used equipment shall be considered or made for equipment
- 23 more than five years old at the time of application for loan
- 24 assistance.
- 25 (5) In every instance, used equipment and apparatus shall
- 26 <u>meet the applicable National Fire Protection Association</u>
- 27 standards, as required above, at the time loan funds are
- 28 <u>advanced</u>.

- 30 Section 2. This act shall take effect immediately.
