AN ACT

Designating a section of Allegheny Avenue (SR 1013) in 1 Philadelphia County, Pennsylvania, as Roxanne H. Jones 2 3 Avenue; DESIGNATING ROUTE 78 IN LEBANON, BERKS, LEHIGH AND 4 NORTHAMPTON COUNTIES AS THE 78TH DIVISION HIGHWAY; 5 DESIGNATING A SECTION OF ROUTE 248 AS THE POW/MIA REMEMBRANCE 6 HIGHWAY; DESIGNATING A BRIDGE IN LEBANON COUNTY AS THE 7 SENATOR CLARENCE F. MANBECK BRIDGE; AND DESIGNATING A PORTION 8 OF STATE ROUTE 0094 IN YORK AND CUMBERLAND COUNTIES AS THE 9 94TH INFANTRY DIVISION MEMORIAL HIGHWAY.

10 The General Assembly of the Commonwealth of Pennsylvania

11 hereby enacts as follows:

12 Section 1. That section of Allegheny Avenue (SR 1013) in

13 SECTION 1. ROXANNE H. JONES AVENUE.

14 (A) DESIGNATION.--THAT SECTION OF ALLEGHENY AVENUE (SR 1013)

15 IN Philadelphia County, beginning on Ridge Avenue and ending at

16 Sedgley Avenue, is hereby designated and shall also be known as

17 Roxanne H. Jones Avenue.

18 Section 2. (B) SIGNS.--The Department of Transportation
19 shall erect and maintain road signs, which shall display the

name of Roxanne H. Jones Avenue, at the beginning and the end of
 the section of the avenue designated in section 1 SUBSECTION
 (A).

4 SECTION 2. 78TH DIVISION HIGHWAY.

5 (A) DESIGNATION.--ROUTE 78 IN LEBANON, BERKS, LEHIGH AND 6 NORTHAMPTON COUNTIES, BEGINNING AT THE I-81 INTERCHANGE IN 7 LEBANON COUNTY AND ENDING AT THE NEW JERSEY STATE LINE, IS 8 HEREBY REDESIGNATED AND SHALL BE KNOWN AS THE 78TH DIVISION 9 HIGHWAY.

(B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
MAINTAIN ROAD SIGNS, WHICH SHALL DISPLAY THE NAME 78TH DIVISION
HIGHWAY AT THE BEGINNING AND THE END OF THE HIGHWAY DESIGNATED
IN SUBSECTION (A).

14 SECTION 3. POW/MIA REMEMBRANCE HIGHWAY.

15 (A) DESIGNATION.--THAT PORTION OF STATE ROUTE 248 SITUATE IN
16 CARBON COUNTY IS HEREBY DESIGNATED THE POW/MIA REMEMBRANCE
17 HIGHWAY.

(B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
MAINTAIN THE APPROPRIATE SIGNS TO INDICATE THIS DESIGNATION TO
MOTORISTS.

21 SECTION 4. SENATOR CLARENCE F. MANBECK BRIDGE.

(A) DESIGNATION.--THE BRIDGE OVER MONROE CREEK WHICH CARRIES
CAMP STRAUSS ROAD, (SR 1022, SEGMENT 50, OFFSET 0064), BETHEL
TOWNSHIP, LEBANON COUNTY, IS HEREBY DESIGNATED AND SHALL BE
KNOWN AS THE SENATOR CLARENCE F. MANBECK BRIDGE.

(B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
MAINTAIN SIGNS WHICH SHALL DISPLAY THE NAME OF SENATOR CLARENCE
F. MANBECK BRIDGE AT EACH END OF THE BRIDGE SO DESIGNATED IN
SUBSECTION (A).

30 SECTION 5. 94TH INFANTRY DIVISION MEMORIAL HIGHWAY. 19970S1193B2193 - 2 - 1 (A) DESIGNATION.--THE PORTION OF STATE ROUTE 0094 FROM THE 2 PENNSYLVANIA LINE TO ITS TERMINUS IN CUMBERLAND COUNTY IS 3 DESIGNATED AND SHALL BE KNOWN AS THE 94TH INFANTRY DIVISION 4 MEMORIAL HIGHWAY.

5 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND 6 MAINTAIN APPROPRIATE SIGNS IDENTIFYING THE ABOVE PORTION OF ROAD 7 AS THE 94TH INFANTRY DIVISION MEMORIAL HIGHWAY.
