AN ACT

1 Making appropriations to the Trustees of the University of  
2 Pennsylvania.

3 The General Assembly of the Commonwealth of Pennsylvania  
4 hereby enacts as follows:

5 Section 1. The following sums, or as much thereof as may be  
6 necessary, are hereby appropriated to the Trustees of the  
7 University of Pennsylvania for the fiscal year July 1, 1998, to  
8 June 30, 1999, for the purposes and in the amounts as shown:

13 Section 2. Payments to the University of Pennsylvania on  
14 account of the appropriations for the items provided in section  
15 1 shall be made quarterly by the Secretary of Education on the  
16 basis of costs during the fiscal year. The secretary shall not  
17 release more than the first quarterly payment until such time as

1 the trustees of the University of Pennsylvania agree in writing  
2 to include a minimum of four members appointed by the General  
3 Assembly. The President pro tempore of the Senate, the Minority  
4 Leader of the Senate, the Speaker of the House of  
5 Representatives and the Minority Leader of the House of  
6 Representatives may each, upon receipt of the written agreement  
7 from the trustees, appoint a nonelected official to serve as a  
8 member of the board and the terms of office shall be coterminous  
9 with that of their appointing authority.

10 Section 3. The University of Pennsylvania shall provide  
11 full, complete and accurate information as may be required by  
12 the Department of Education or the chairman or the minority  
13 chairman of the Appropriations Committee of the Senate or the  
14 chairman or the minority chairman of the Appropriations  
15 Committee of the House of Representatives.

16 Section 4. The University of Pennsylvania shall report its  
17 revenues and expenditures and present its financial statements  
18 in accordance with generally accepted accounting principles and  
19 procedures for educational institutions as set forth in the  
20 "Higher Education Finance Manual (1975)" and the "Commonwealth  
21 of Pennsylvania Budget Instructions for the State System of  
22 Higher Education, State-Related Universities and Non-State-  
23 Related Colleges and Universities."

24 Section 5. The trustees of the University of Pennsylvania  
25 shall report on forms provided by the Department of Education to  
26 both the chairman and minority chairman of the Appropriations  
27 Committee of the Senate and the chairman and minority chairman  
28 of the Appropriations Committee of the House of Representatives  
29 by September 30, 1999, on how State-appropriated funds were  
30 expended for fiscal year 1998-1999 to reduce the costs to

1 Pennsylvania resident students or to provide services to  
2 Pennsylvania residents.

3 Section 6. This act shall take effect July 1, 1998, or  
4 immediately, whichever is later.
