AN ACT

- 1 Relating to the certified fire protection specialist profession;
- and providing protection to the profession of certified fire
- 3 protection specialist.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Protection
- 8 Act for the Certified Fire Protection Specialist Profession.
- 9 Section 2. Purpose.
- 10 The purpose of this act is to provide legal recognition to
- 11 the certified fire protection specialist profession as well as
- 12 provide assurance to the public that individuals representing
- 13 themselves as practicing professionals of certified fire
- 14 protection specialist have met the required minimum
- 15 qualifications, thereby protecting the public health and safety
- 16 from harm.
- 17 Section 3. Definitions.
- 18 The following words and phrases when used in this act shall

- 1 have the meanings given to them in this section unless the
- 2 context clearly indicates otherwise:
- 3 "Accredited college or university." A college or university
- 4 accredited by one of the following accrediting agencies:
- 5 (1) Middle States Association of Schools and Colleges.
- 6 (2) New England Association of Schools and Colleges.
- 7 (3) North Central Association of Colleges and Schools.
- 8 (4) Northwest Association of Schools and Colleges.
- 9 (5) Southern Association of Colleges and Schools.
- 10 (6) Western Association of Schools and Colleges.
- 11 (7) Any college/university offering a degree that is
- 12 accredited by an accrediting organization that in turn is
- 13 recognized by the Council on Higher Education Accreditation
- 14 (CHEA).
- 15 A college or university that is located outside the United
- 16 States will be considered on the basis of its accreditation
- 17 status in the education system that has jurisdiction.
- 18 "Accredited program." A program that is accredited by the
- 19 Accreditation Board of Engineering and Technology (ABET).
- 20 "Certified Fire Protection Specialist" or "CFPS." A person
- 21 who has been certified as a CFPS by the Certified Fire
- 22 Protection Specialist Board and whose certification has not
- 23 lapsed or been revoked.
- 24 "Education and experience." The individual must meet one of
- 25 the following qualifications:
- 26 (1) (i) a baccalaureate degree from an accredited
- 27 college or university in fire protection engineering,
- 28 engineering, fire technology, chemistry, physics or a
- 29 closely related physical science;
- 30 (ii) two years' verifiable progressive work

1 experience in the fire protection field; and (iii) satisfactory completion of the Certified Fire 2 3 Protection Specialist written examination; or 4 (i) a baccalaureate degree from an accredited college or university that contains at least 60 semester 5 hours in science, mathematics, engineering or technology 6 courses, with at least 15 of these hours at the upper 7 level. A degree that is heavily comprised of only one of 8 these subject areas, in the absence of others, may be 9 10 judged unacceptable. An unacceptable bachelor's degree may be remedied by additional fire science coursework 11 12 from an accredited college or university or by completion 13 of a related graduate degree from an accredited college or university; 14 15 (ii) two years' verifiable progressive work experience in the fire protection field; and 16 17 (iii) satisfactory completion of the Certified Fire 18 Protection Specialist written examination; or 19 (i) an associate degree from an accredited college 20 or university in fire technology or other related field; four years' verifiable progressive work 21 22 experience in the fire protection field; and 23 (iii) satisfactory completion of the Certified Fire 24 Protection Specialist written examination; or 25 (i) a high school diploma or general educational 26 development diploma, plus coursework from a recognized 27 fire school or an accredited college or university; 28 (ii) six years' verifiable progressive work experience in the fire protection field; and 29 30 (iii) satisfactory completion of the Certified Fire

- 1 Protection Specialist written examination.
- 2 "Experience." The individual has demonstrated work
- 3 experience, including the ability to:
- 4 (1) anticipate and recognize workplace environmental
- factors and stresses, such as chemical or physical, and
- 6 understand their effects on people and their well-being;
- 7 (2) evaluate, through sampling and testing, the
- 8 magnitude of these factors and stresses;
- 9 (3) prescribe controls to mitigate safety, fire and
- 10 health hazards and the potential for injury, illness or
- 11 property damage; or
- 12 (4) prescribe methods or devices, including, but not
- limited to, engineering, administrative, personal protective
- 14 equipment or training, to eliminate, control or reduce such
- factors, hazards and stresses to alleviate the effects.
- 16 Section 4. Professional regulation.
- 17 An individual shall meet the requirements and qualifications
- 18 as set out in this act before the individual may use the title
- 19 or represent himself to the public as a Certified Fire
- 20 Protection Specialist (CFPS).
- 21 Section 5. Enforcement.
- 22 (a) Unfair practice. -- It is an unfair practice for any
- 23 person to represent himself as a Certified Fire Protection
- 24 Specialist (CFPS) unless he complies with the requirements of
- 25 this act.
- 26 (b) Penalty.--A person who violates the provisions of this
- 27 act is subject to a civil penalty of not more than \$1,000 per
- 28 day for each day that the violation occurs.
- 29 Section 6. Professional practice.
- 30 No entity of State or local government shall by rule or

- 1 otherwise prohibit or restrict the practice of certified fire
- 2 protection by any qualified individual who complies with the
- 3 provisions established by or pursuant to this act, except where
- 4 authorized by State law to regulate a specific activity that may
- 5 include the practice of certified fire protection.
- 6 Section 7. Effective date.
- 7 This act shall take effect in 60 days.
