11	The power of the several courts of this Commonwealth to issue
12	attachments and to impose summary punishments for contempts of
13	court shall be restricted to the following cases:

15	(4) When a party to litigation, engaging in a course of
16	conduct or repeatedly committing acts which alarm or
17	seriously annoy an adverse party and which serve no
18	legitimate purpose.
