1 2 3	Amending Titles 30 (Fish) and 34 (Game) of the Pennsylvania Consolidated Statutes, providing for trespassing and penalties.
4	The General Assembly of the Commonwealth of Pennsylvania
5	hereby enacts as follows:
6	Section 1. Title 30 of the Pennsylvania Consolidated
7	Statutes is amended by adding a section to read:
8	§ 729. Trespassing on commission lands or waters.
9	(a) General rule No person shall, knowing that he is not
10	licensed or privileged to do so:
11	(1) enter or remain on any commission lands or waters;
12	(2) enter or remain on any commission lands or waters
13	when such lands or waters are posted in a manner prescribed
14	by law or reasonably likely to come to the person's attention
15	or are fenced or enclosed in a manner manifestly designed to
16	exclude trespassers or to confine fish or animals; or
17	(3) enter or remain on any commission lands or waters
18	and defy an order not to enter or to leave that has been

- 1 personally communicated to him by the commission, the
- 2 executive director, a waterways conservation officer, a
- 3 <u>deputy waterways conservation officer or other authorized</u>
- 4 person.
- 5 (b) Penalties. -- Any person who violates this section commits
- 6 <u>an offense, which offense shall be graded as follows:</u>
- 7 (1) A violation of subsection (a)(1) constitutes a
- 8 <u>summary offense and is punishable by imprisonment for a term</u>
- 9 of not more than 90 days and a fine of not less than \$100 nor
- 10 more than \$300.
- 11 (2) A violation of subsection (a)(2) constitutes a
- 12 <u>misdemeanor of the third degree and is punishable by</u>
- imprisonment for a term of not more than one year and a fine
- of not less than \$250 nor more than \$2,500.
- 15 (3) A violation of subsection (a)(3) constitutes a
- 16 <u>misdemeanor of the second degree and is punishable by</u>
- imprisonment for a term of not more than two years and a fine
- of not less than \$500 nor more than \$5,000.
- 19 (c) Definition. -- As used in this section, "commission lands
- 20 or waters means any lands or waters owned, leased or otherwise
- 21 controlled by the commission.
- 22 Section 2. Title 34 is amended by adding a section to read:
- 23 § 742. Trespassing on commission lands or waters.
- 24 (a) General rule. -- No person shall, knowing that he is not
- 25 <u>licensed or privileged to do so:</u>
- 26 (1) enter or remain on any commission lands or waters;
- 27 (2) enter or remain on any commission lands or waters
- when such lands or waters are posted in a manner prescribed
- 29 <u>by law or reasonably likely to come to the person's attention</u>
- 30 or are fenced or enclosed in a manner manifestly designed to

- 1 <u>exclude trespassers or to confine fish or animals; or</u>
- 2 (3) enter or remain on any commission lands or waters
- 3 and defy an order not to enter or to leave that has been
- 4 personally communicated to him by the commission, the
- 5 <u>director</u>, an officer or other authorized person.
- 6 (b) Penalties. -- Any person who violates this section commits
- 7 <u>an offense, which offense shall be graded as follows:</u>
- 8 (1) A violation of subsection (a)(1) constitutes a
- 9 <u>summary offense and is punishable by imprisonment for a term</u>
- of not more than 90 days and a fine of not less than \$100 nor
- 11 <u>more than \$300.</u>
- 12 (2) A violation of subsection (a)(2) constitutes a
- misdemeanor of the third degree and is punishable by
- imprisonment for a term of not more than one year and a fine
- of not less than \$250 nor more than \$2,500.
- 16 (3) A violation of subsection (a)(3) constitutes a
- 17 misdemeanor of the second degree and is punishable by
- imprisonment for a term of not more than two years and a fine
- of not less than \$500 nor more than \$5,000.
- 20 (c) Definition.--As used in this section, "commission lands
- 21 or waters" means any lands or waters owned, leased or otherwise
- 22 controlled by the commission.
- 23 Section 3. This act shall take effect in 60 days.
