AN ACT

- 1 Providing for pet sterilization; establishing the Pet Population
- 2 Control Fund in the State Treasury; providing for a
- 3 Spay/Neuter Companion Animals license plate; establishing the
- 4 Pet Population Control Program; providing for financial
- 5 incentives for pet sterilization; and providing penalties.
- 6 The General Assembly finds and declares that the purposes of
- 7 this act are to:
- 8 (1) Reduce the population of unwanted and stray dogs and
- 9 cats by encouraging the owners of these pets to have them
- 10 permanently sexually sterilized, thereby reducing potential
- 11 threats to public health and safety posed by the growing
- 12 population.
- 13 (2) Provide financial assistance for pet sterilization.
- 14 The General Assembly of the Commonwealth of Pennsylvania
- 15 hereby enacts as follows:
- 16 Section 1. Short title.

- 1 This act shall be known and may be cited as the Pet
- 2 Population Control Act.
- 3 Section 2. Definitions.
- 4 The following words and phrases when used in this act shall
- 5 have the meanings given to them in this section unless the
- 6 context clearly indicates otherwise:
- 7 "Department." The Treasury Department of the Commonwealth.
- 8 "Fund." The Pet Population Control Fund.
- 9 "Pet." A dog or cat.
- 10 "Veterinary practice." The practice of veterinary medicine
- 11 by a person licensed under the act of December 27, 1974
- 12 (P.L.995, No.326), known as the Veterinary Medicine Practice
- 13 Act.
- 14 Section 3. Pet Population Control Fund.
- 15 (a) Establishment.--There is hereby established a special
- 16 fund in the State Treasury to be known as the Pet Population
- 17 Control Fund, to which shall be credited all funds collected
- 18 under this act from the Spay/Neuter Companion Animals license
- 19 plate sales.
- 20 (b) Spay/Neuter Companion Animals license plate. -- Upon
- 21 application to the Department of Transportation of any person,
- 22 accompanied by a fee of \$35 which shall be in addition to the
- 23 annual registration fee, the Department of Transportation shall
- 24 issue a Spay/Neuter Companion Animals license plate for a
- 25 passenger car or other vehicle with a registered gross weight of
- 26 not more than 9,000 pounds. The Pet Population Control Fund
- 27 shall receive \$15 of each additional fee for this plate.
- 28 (c) Interest. -- Any interest earned by moneys in the fund
- 29 shall accrue to the fund.
- 30 (d) Requisitions.--The department shall requisition from the

- 1 fund all available amounts necessary to provide a reimbursement
- 2 program for the sterilization of pets in this Commonwealth.
- 3 (e) Expenses.--As much as may be necessary of the moneys in
- 4 the fund may be used to pay the expenses of the department in
- 5 administering its duties under this act.
- 6 Section 4. Pet Population Control Program.
- 7 (a) Establishment.--The department shall establish and
- 8 implement the Pet Population Control Program which shall provide
- 9 a reimbursement program for pet owners.
- 10 (b) Rules and regulations.--The department may promulgate
- 11 rules and regulations to carry out the purposes of the act and
- 12 cause them to be displayed in a conspicuous location in all
- 13 veterinary practices, pet stores, public and private animal
- 14 shelters and kennels.
- 15 (c) Advertisement.--The Treasury Department and the
- 16 Department of Transportation shall advertise the reimbursement
- 17 program in a manner most likely to reach all pet owners. An
- 18 enclosure announcing the Spay/Neuter Companion Animals license
- 19 plate shall be included with the initial and subsequent annual
- 20 registration fee notices.
- 21 Section 5. Reimbursement of pet owners.
- 22 (a) Amount.--Provided sufficient moneys exist in the Pet
- 23 Population Control Fund, reimbursements shall be made to pet
- 24 owners for up to 50% of the veterinarian's fee to spay or neuter
- 25 a pet in an amount determined by the department, not to exceed
- 26 the following amounts:
- 27 (1) For cat neuters, \$20.
- 28 (2) For cat spays, \$35.
- 29 (3) For dog neuters, \$40.
- 30 (4) For dog spays, \$55.

- 1 (b) Procedure. -- Any person submitting a pet for sexual
- 2 sterilization who wishes to receive reimbursement under this act
- 3 shall:
- 4 (1) Be a resident of this Commonwealth.
- 5 (2) Certify in writing that he is the owner of the pet
- or authorized by the owner to present the pet for the
- 7 procedure.
- 8 (3) Pay to the veterinary practice the fee for the
- 9 sterilization procedure.
- 10 (4) Submit an application for reimbursement to the
- 11 department.
- 12 (c) Application form.--The application form for
- 13 reimbursement shall include, but not be limited to, the
- 14 following:
- 15 (1) The name and address of the pet owner.
- 16 (2) The name and address of the veterinarian who
- 17 performed the sterilization procedure.
- 18 (3) A description of the pet as to species, breed and
- 19 sex.
- 20 (4) A brief description of the procedure performed.
- 21 (5) An affidavit by the veterinary practice stating that
- the sterilization has been completed, the amount charged and
- 23 the name of the person who paid for the procedure.
- 24 (6) A copy of the receipt by the pet owner of the amount
- 25 paid for the procedure.
- 26 (7) The name of any other organization providing
- 27 financial assistance, in whole or in part, for the cost of
- the sterilization procedure and the amount provided.
- 29 (d) Application for reimbursement.--Application for the
- 30 refund must be made no later than six months from the date of

- 1 the sterilization procedure.
- 2 Section 6. Penalty.
- 3 (a) Offenses defined.--A person commits a misdemeanor of the
- 4 second degree if he knowingly:
- 5 (1) Furnishes the department with false information
- 6 concerning the actual amount paid for the sterilization
- 7 procedure by the pet owner or submits a fraudulent
- 8 application for reimbursement under this act.
- 9 (2) Furnishes any veterinary practice with inaccurate
- information concerning the ownership of a pet submitted for a
- 11 pet sterilization procedure.
- 12 (b) Violation of Veterinary Medicine Practice Act.--
- 13 Providing false information under this act by a veterinarian
- 14 shall be a violation of the act of December 27, 1974 (P.L.995,
- 15 No.326), known as the Veterinary Medicine Practice Act, and
- 16 shall render the veterinarian ineligible for further
- 17 participation in the reimbursement program.
- 18 (c) Reports by department. -- The department shall report all
- 19 violations of this act to:
- 20 (1) Appropriate law enforcement authorities.
- 21 (2) The State Board of Veterinary Medicine.
- 22 Section 7. Effective date.
- 23 This act shall take effect in 90 days.
