AN ACT

- Amending the act of June 23, 1931 (P.L.923, No.309), entitled 2 "An act to prohibit the employment in any factory or cannery, 3 or in berry, fruit and vegetable raising and harvesting, in this Commonwealth, of any child under sixteen years of age, 5 residing in another state, during the time when the laws of the state of such child's residence require his attendance at 7 school, to regulate the conditions of such employment of such child during the time when the laws of the state of such 8 9 child's residence do not require his attendance at school, to 10 prescribe the duties of the employer of such child, to 11 provide for the issuance of school requirement certificates 12 for children resident in this Commonwealth desiring such 13 employment in other states; providing for the enforcement of 14 this act by certain officers, and defining the procedure in 15 prosecutions thereunder; providing penalties for the 16 violation of the provisions thereof; and repealing all acts 17 or parts of acts inconsistent therewith, "further providing for truant officers. 18
- 19 The General Assembly of the Commonwealth of Pennsylvania
- 20 hereby enacts as follows:
- 21 Section 1. Section 5 of the act of June 23, 1931 (P.L.923,
- 22 No. 309), entitled "An act to prohibit the employment in any
- 23 factory or cannery, or in berry, fruit and vegetable raising and
- 24 harvesting, in this Commonwealth, of any child under sixteen

- 1 years of age, residing in another state, during the time when
- 2 the laws of the state of such child's residence require his
- 3 attendance at school, to regulate the conditions of such
- 4 employment of such child during the time when the laws of the
- 5 state of such child's residence do not require his attendance at
- 6 school, to prescribe the duties of the employer of such child,

- 12 of the provisions thereof; and repealing all acts or parts of
- 13 acts inconsistent therewith," is repealed.
- 14 Section 2. This act shall take effect immediately.
