AN ACT

- Amending the act of May 1, 1933 (P.L.103, No.69), entitled, as reenacted and amended, "An act concerning townships of the 2 3 second class; and amending, revising, consolidating and 4 changing the law relating thereto, "further providing for 5 vacancies in certain offices. The General Assembly of the Commonwealth of Pennsylvania 6 7 hereby enacts as follows: 8 Section 1. Section 407 of the act of May 1, 1933 (P.L.103,
- No.69), known as The Second Class Township Code, reenacted and
- 10 amended November 9, 1995 (P.L.350, No.60), is amended to read:
- 11 Section 407. Vacancies in General .-- If the electors of any
- 12 township fail to choose a supervisor, tax collector, auditor or
- 13 assessor or if any person elected to any office fails to serve
- 14 in the office or if a vacancy occurs in the office by death,
- 15 resignation, removal from the township or otherwise, the board
- 16 of supervisors may appoint a successor who is an elector of the
- 17 township and has resided in that township continuously for at
- 18 least one year prior to their appointment, and, upon their

- 1 failure to make the appointment within thirty days after the
- 2 vacancy occurs, the vacancy shall be filled within fifteen
- 3 additional days by the vacancy board. The vacancy board shall
- 4 consist of the board of supervisors and one elector of the
- 5 township, who shall be appointed by the board of supervisors at
- 6 the board's first meeting each calendar year or as soon after
- 7 that as practical and who shall act as chairman of the vacancy
- 8 board. If the vacancy board fails to fill the position within
- 9 fifteen days, the chairman shall, or if there is a vacancy in
- 10 the chairmanship the remaining members of the vacancy board
- 11 shall, petition the court of common pleas to fill the vacancy.
- 12 If two or more vacancies in the office of supervisor occur on a
- 13 three-member board or three or more vacancies on a five-member
- 14 board, the court of common pleas shall fill the vacancies upon
- 15 presentation of petition signed by not less than fifteen
- 16 electors of the township. The successor so appointed shall hold
- 17 the office until the first Monday in January after the first
- 18 municipal or general election which occurs more than sixty days
- 19 after the vacancy occurs, at which election an eligible person
- 20 shall be elected for the unexpired term.
- 21 Section 2. This act shall apply to vacancies occurring on or
- 22 after the effective date of this act.
- 23 Section 3. This act shall take effect in 60 days.
