1	Designating a portion of Route 422 in Berks County, Pennsylvania

12	The General Assembly of the Commonwealth of Pennsylvania	
13	hereby enacts as follows:	

- 14 Section 1. Albert Boscov Commemorative Highway.
- 15 (a) Designation.--East of Reading, beginning at the
- 16 intersection with Route 562 and continuing east on Route 422
- 17 until ending at Shellborne Road, is hereby designated and shall
- 18 be known as the Albert Boscov Commemorative Highway.
- 19 (b) Signs.--The Department of Transportation shall erect and
- 20 maintain road signs, which shall display the name of Albert
- 21 Boscov Commemorative Highway, at the beginning and the end of
- 22 the section of the highway designated in subsection (a).

- 1 Section 2. Peter DiNicola Bridge.
 2 (a) Findings. The General Assembly hereby finds and
 3 declares as follows:
 4 (1) Peter DiNicola, born in 1897, was an Italian
 5 immigrant who settled in the Harborcreek Station Road area
- 7 (2) Peter DiNicola served with the 12th Pennsylvania
 8 State Militia and was activated during the Pancho Villa
 9 uprising in Mexico.

south of Interstate 90, near Erie, Erie County in 1913.

- (3) Prior to his death in 1957, Peter DiNicola developed
 a reputation as a skilled bricklayer and builder and between
 12 1930 to the mid 1950's became known as one of the leading
 13 contractors in the Eric area, particularly in the communities
 14 of Harborcreek and Wesleyville.
- 15 (4) Like thousands of other immigrants of his time,
 16 Peter DiNicola made a lasting contribution to the quality and
 17 character of his community.
- 18 (b) Designation authorized. The bridge carrying
- 19 Pennsylvania Route 430 in Harborcreek Township in Erie County
- 20 over Interstate 90, is hereby designated and shall hereafter be
- 21 known as the Peter DiNicola Bridge in honor of immigrant builder
- 22 and contractor Peter DiNicola's many contributions to his
- 23 community, to his county and to the Commonwealth.
- 24 (c) Signs. The Department of Transportation shall erect
- 25 appropriate signs at each end of the bridge displaying the
- 26 designation made by this section.
- 27 SECTION 2. KOREAN WAR VETERANS MEMORIAL HIGHWAY.
- 28 (A) DESIGNATION.--THE PORTION OF STATE ROUTE 318 FROM THE
- 29 OHIO STATE LINE TO THE INTERSECTION OF STATE ROUTE 18 IN MERCER
- 30 COUNTY IS DESIGNATED AND SHALL BE KNOWN AS THE KOREAN WAR

- 1 VETERANS MEMORIAL HIGHWAY.
- 2 (B) SIGNING.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT
- 3 AND MAINTAIN APPROPRIATE SIGNS IDENTIFYING THE ABOVE PORTION OF
- 4 ROAD AS THE KOREAN WAR VETERANS MEMORIAL HIGHWAY.
- 5 SECTION 3. "BIG SIX" CHRISTY MATHEWSON MEMORIAL HIGHWAY.
- 6 (A) DESIGNATION.--THE PORTION OF SR 6 BETWEEN ITS
- 7 INTERSECTION WITH SR 107 IN WYOMING COUNTY TO LA PLUME IN
- 8 LACKAWANNA COUNTY IS HEREBY DESIGNATED AS THE "BIG SIX" CHRISTY
- 9 MATHEWSON MEMORIAL HIGHWAY.
- 10 (B) SIGNING.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT
- 11 APPROPRIATE SIGNS TO INDICATE THIS DESIGNATION.
- 12 SECTION 4. REPRESENTATIVE MARION L. MUNLEY AND POLICE CHIEF
- 13 DONALD MUNLEY EXIT.
- 14 (A) DESIGNATION.--THE ON AND OFF RAMP IN ARCHBALD DESIGNATED
- 15 AS EXIT 4 OF THE ROBERT P. CASEY HIGHWAY IS REDESIGNATED AS THE
- 16 REPRESENTATIVE MARION L. MUNLEY AND POLICE CHIEF DONALD MUNLEY
- 17 EXIT.
- 18 (B) SIGNING.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT

- 19 AND MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE
- 20 HIGHWAY AND THE EXIT.
- 21 Section 3 5. Effective date.
- 22 This act shall take effect in 60 days.
