5 (C.1) TELECOMMUNICATION DEVICES TO INMATES PROHIBITED. -- A PERSON COMMITS A MISDEMEANOR OF THE FIRST DEGREE IF, WITHOUT THE 6 7 WRITTEN PERMISSION OF THE SUPERINTENDENT, WARDEN OR OTHERWISE 8 AUTHORIZED INDIVIDUAL IN CHARGE OF A STATE OR COUNTY 9 CORRECTIONAL INSTITUTION OR HOSPITAL, THE PERSON SELLS, GIVES OR 10 FURNISHES TO ANY INMATE IN A PRISON OR IN A MENTAL HOSPITAL, OR ANY BUILDING APPURTENANT THERETO, OR PUTS IN ANY PLACE WHERE IT 11 12 MAY BE SECURED BY AN INMATE OF A PRISON OR MENTAL HOSPITAL, ANY 13 TELECOMMUNICATION DEVICE. 14 (C.2) POSSESSION OF TELECOMMUNICATION DEVICES BY INMATES 15 PROHIBITED. -- AN INMATE IN A PRISON OR MENTAL HOSPITAL, OR ANY 16 BUILDING APPURTENANT THERETO, COMMITS A MISDEMEANOR OF THE FIRST 17 DEGREE IF THE INMATE HAS IN HIS POSSESSION ANY TELECOMMUNICATION 18 DEVICE WITHOUT THE WRITTEN PERMISSION OF THE SUPERINTENDENT, 19 WARDEN OR OTHERWISE AUTHORIZED INDIVIDUAL IN CHARGE OF A STATE 20 OR COUNTY CORRECTIONAL INSTITUTION OR MENTAL HOSPITAL. \* \* \* 21 22 (E) DEFINITION.--AS USED IN THIS SECTION, THE TERM 23 "TELECOMMUNICATION DEVICE" MEANS ANY TYPE OF INSTRUMENT, DEVICE, 24 MACHINE OR EQUIPMENT WHICH IS CAPABLE OF TRANSMITTING 25 TELEPHONIC, ELECTRONIC, DIGITAL, CELLULAR OR RADIO 26 COMMUNICATIONS OR ANY PART OF SUCH INSTRUMENT, DEVICE, MACHINE 27 OR EQUIPMENT WHICH IS CAPABLE OF FACILITATING THE TRANSMISSION 28 OF TELEPHONIC, ELECTRONIC, DIGITAL, CELLULAR OR RADIO 29 COMMUNICATIONS.
