AN ACT

- 1 Amending Title 62 (Procurement) of the Pennsylvania Consolidated
- 2 Statutes, further providing for supplies manufactured and
- 3 services performed by persons with disabilities.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 520 of Title 62 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 520. Supplies manufactured and services performed by persons
- 9 with disabilities.
- 10 (a) General rule. -- Contracts for supplies manufactured by
- 11 and services performed by persons with disabilities shall be
- 12 entered into in accordance with this section without the
- 13 requirement for competitive bidding. Persons with disabilities
- 14 must make an appreciable contribution in manufacturing an item

- 1 <u>or performing a service.</u>
- 2 (b) Fair market price. -- Upon request [of] TO the department
- 3 and notice to the purchasing agency, the department shall
- 4 determine the fair market price of any supply manufactured by or
- 5 service performed by persons with disabilities and offered for
- 6 sale to any Commonwealth agency by an agency for persons with
- 7 disabilities. The department shall revise the prices in
- 8 accordance with changing market conditions.
- 9 (c) Distribution. -- At the request of the department, the
- 10 Department of Public Welfare or a nonprofit agency with the
- 11 approval of the Department of Public Welfare shall facilitate
- 12 the distribution of orders for supplies manufactured by or
- 13 services performed by persons with disabilities among agencies
- 14 for persons with disabilities.
- 15 (d) Procurement of supplies manufactured and services
- 16 performed by persons with disabilities. -- Except as provided in
- 17 subsection (e), all supplies manufactured by and services
- 18 furnished by persons with disabilities shall be procured in
- 19 accordance with applicable specifications of the department or
- 20 other Commonwealth agencies from any agency for persons with
- 21 disabilities whenever the supplies and services are available at
- 22 a price determined by the department to be the fair market
- 23 price. The head of a purchasing agency shall annually discuss
- 24 its needs for supplies or services with any agency for persons
- 25 with disabilities.
- 26 (e) Procurement from Commonwealth agency.--If any supply
- 27 manufactured by or any service performed by persons with
- 28 disabilities and offered for sale is available for procurement
- 29 from any Commonwealth agency and this part or any other statute
- 30 requires the procurement of the supply or service from the

- 1 Commonwealth agency, then the procurement of the supply or
- 2 service shall be made in accordance with the other provisions.
- 3 (f) Exception.--Notwithstanding subsection (h), when the
- 4 Commonwealth enters into a contract under this section for the
- 5 operation of the Commonwealth's driver's license photo centers,
- 6 at least 70% of the amount paid by the Commonwealth shall be
- 7 used to cover payment of wages and salaries to persons with
- 8 disabilities and to cover actual manufacturing costs, real
- 9 estate lease costs, property insurance and other costs which are
- 10 specifically required by contract.
- 11 (g) Application.--
- 12 (1) This section shall not supersede any contract
- currently in force between a Commonwealth agency and another
- 14 party.
- 15 (2) Nothing in this section shall be construed as
- 16 conferring upon any party any right or interest in any
- 17 contract entered into with the Commonwealth.
- 18 (h) Definitions.--As used in this section, the following
- 19 words and phrases shall have the meanings given to them in this
- 20 subsection:
- 21 "Agency for persons with disabilities." Any charitable,
- 22 nonprofit agency incorporated under the laws of this
- 23 Commonwealth and approved by the department through which
- 24 persons with disabilities manufacture supplies or perform
- 25 services in this Commonwealth.
- 26 <u>"Appreciable contribution."</u>
- 27 (1) Except as provided in IN ADDITION TO paragraph (2),
- 28 <u>the department shall determine whether the contribution by</u>
- 29 <u>individuals with disabilities is appreciable. Persons with</u>
- 30 disabilities must make an appreciable contribution in

- 1 manufacturing an item A SUPPLY or performing a service.
- 2 (2) At least 75% of the personnel either engaged in the
- 3 <u>direct labor of manufacturing of a product SUPPLY or engaged</u> <-

- 4 <u>in the direct labor in performing a service in this</u>
- 5 <u>Commonwealth must be visually impaired, mentally retarded,</u>
- 6 mentally ill or physically disabled. In addition, at least
- 7 75% of the amount paid by the Commonwealth agency for the
- 8 product SUPPLY or the service shall be remitted to the agency <--
- 9 <u>for persons with disabilities to cover payment of wages and</u>
- salaries to persons with disabilities and to cover other
- 11 <u>actual manufacturing costs incurred by the agency for persons</u>
- with disabilities in manufacturing of a product SUPPLY.
- 13 <u>"Manufactured." The transformation of raw materials or the</u>
- 14 assembly of essential component parts or a combination of both
- 15 in the production of an item A SUPPLY, which is different in
- 16 <u>form</u>, <u>composition</u> or <u>character</u> from the raw materials or the
- 17 <u>essential component parts.</u>
- 18 "Mentally ill." A severe personality or behavioral disorder
- 19 that constitutes a substantial impediment to employment and
- 20 which prevents the individual from engaging in normal
- 21 <u>competitive employment. Those disorders caused by substance</u>
- 22 abuse or chemical dependency are not included.
- 23 "Mentally retarded." Subaverage general intellectual
- 24 functioning which originates during the developmental period and
- 25 is associated with the impairment of maturation, learning or
- 26 social adjustment.
- 27 "Performed." Labor provided to do the work to fulfill the
- 28 requirements of the contract.
- 29 "Persons with a disability." A person who is visually
- 30 impaired, mentally retarded, mentally ill or physically

- 1 disabled.
- 2 "Physically disabled." A limitation of most activities and
- 3 functioning by virtue of a severe impairment of the various
- 4 bodily systems which cannot be eliminated, modified or
- 5 substantially reduced by the usual rehabilitation services and
- 6 which precludes competitive employment.
- 7 <u>"Services." While "services" is defined in section 103</u>
- 8 (relating to definitions) of this part, for the purposes of this
- 9 section, the term specifically includes such packaging or
- 10 repackaging which, as determined by the department, provides a
- 11 <u>substantial</u> and real benefit to the Commonwealth agency which
- 12 needs the supplies to be packaged or repackaged. When packaging
- 13 <u>or repackaging services are to be provided to a Commonwealth</u>
- 14 agency by an agency for persons with disabilities, the
- 15 Commonwealth agency shall make the arrangements for the
- 16 procurement of the supplies to be packaged or repackaged.
- 17 Packaging or repackaging shall not be considered "services" if
- 18 the manufacturer usually packages or repackages the supplies, in
- 19 the quantity required by the agency, as a part of its
- 20 <u>manufacturing and distribution process.</u>
- 21 ["Supply manufactured by or service performed by person with
- 22 disabilities." At least 75% of the personnel either engaged in
- 23 the direct labor of manufacturing of a product or engaged in the
- 24 direct labor in performing a service in this Commonwealth must
- 25 be visually impaired, mentally retarded or physically disabled.
- 26 In addition, at least 75% of the amount paid by the Commonwealth
- 27 agency for the product or the service shall be remitted to the
- 28 agency for persons with disabilities to cover payment of wages
- 29 and salaries to persons with disabilities and to cover other
- 30 actual manufacturing costs incurred by the agency for persons

- 1 with disabilities in manufacturing of a product.]
- 2 "Visually impaired." A condition in which central visual
- 3 acuity does not exceed 20/200 in the better eye with correcting
- 4 lenses or in which the widest diameter of the visual field
- 5 subtends an angle no greater than 20 degrees.
- 6 Section 2. This act shall take effect in 30 days.
