AN ACT

1 Amending the act of July 28, 1953 (P.L.723, No.230), entitled,
2 as amended, "An act relating to counties of the second class
3 and second class A; amending, revising, consolidating and
4 changing the laws relating thereto," providing for insurance <—
5 and other employee benefits; further providing for tax levies
6 and for authority of county commissioners to make contracts;
7 amending provisions relating to acquisition, use, leasing and
8 disposing of property for county and to construction or
9 alteration of county buildings; further prohibiting
10 disorderly conduct in and about courthouses and jails;
11 further providing for joining with municipality in improving
12 certain streets and highways and for parks and comfort
13 houses; amending provisions relating to monuments and
14 memorials; further providing for acquiring of property for
15 certain purposes and for authority to provide for morgues;
16 amending provisions relating to bridges, viaducts, culverts,
17 roads and recreation places; further providing for authority
18 to provide parks and for title acquired in eminent domain
19 proceedings; and making editorial changes. FURTHER PROVIDING <—
20 FOR TAX LEVIES, FOR AUTHORITY TO SELL OR LEASE REAL PROPERTY,
21 FOR SEPARATE SPECIFICATIONS FOR CONTRACT AND FOR EMINENT
22 DOMAIN PROCEEDINGS.

23 The General Assembly of the Commonwealth of Pennsylvania
24 hereby enacts as follows:

25 Section 1. The act of July 28, 1953 (P.L.723, No.230), known <—

3 ~~Section 1820.1. Insurance and Other Employe Benefits. In~~  
4 ~~addition to any other authorized compensation, county~~  
5 ~~commissioners and other county officers and their dependents~~

14 SECTION 1. SECTION 1970 OF THE ACT OF JULY 28, 1953  
15 (P.L.723, NO.230), KNOWN AS THE SECOND CLASS COUNTY CODE,  
16 AMENDED FEBRUARY 14, 1986 (P.L.16, NO.6), IS AMENDED TO READ:

17 Section 1970. Tax Levies.--No tax shall be levied on  
18 personal property taxable for county purposes where the rate of  
19 taxation thereon is fixed by law other than at the rate so  
20 fixed. The county commissioners shall fix, by resolution, the  
21 rate of taxation for each year. The tax levied shall be for the  
22 purpose of creating a general fund to pay expenses incurred for  
23 general county purposes, for the payment of the matters  
24 connected with roads provided for in subsection (g) of section  
25 2901 hereof, for the payment of the matters connected with parks  
26 and related matters provided for in sections 3007 and 3035  
27 hereof. No such tax in any county of the second class, shall in  
28 any one year exceed the rate of twenty-five mills on every  
29 dollar of the adjusted valuation: Provided, however, That the  
30 rate of taxation for payment of interest and principal on any

1 indebtedness incurred pursuant to the act of July 12, 1972  
2 (P.L.781, No.185), known as the "Local Government Unit Debt  
3 Act," or any prior or subsequent act governing the incurrence of  
4 indebtedness of the county shall be unlimited. No tax for  
5 general county purposes in any county of the second class A  
6 shall in any one year exceed the rate of [thirty] forty mills on  
7 every dollar of the adjusted valuation: Provided, however, That  
8 the rate of taxation for payment of interest and principal on  
9 any indebtedness incurred pursuant to the act of July 12, 1972  
10 (P.L.781, No.185), known as the "Local Government Unit Debt  
11 Act," or any prior or subsequent act governing the incurrence of  
12 indebtedness of the county shall be unlimited. In fixing the  
13 rate of taxation, the county commissioners if the rate is fixed  
14 in mills, shall also include in the resolution a statement  
15 expressing the rate of taxation in dollars and cents on each one  
16 hundred dollars of assessed valuation of taxable property.

23 ~~Section 2001. County Commissioners to Make Contracts. The~~  
24 ~~County Commissioners may make contracts for lawful purposes and~~  
25 ~~for the purposes of carrying into execution the provisions of~~  
26 ~~this section and the laws of the Commonwealth.~~

27 ~~(a) Except as provided in subsection (a.1), all contracts or~~  
28 ~~purchases in excess of ten thousand dollars (\$10,000) shall be~~  
29 ~~in writing and, except those hereinafter mentioned, and except~~  
30 ~~as provided by the act of October 27, 1979 (P.L.241, No.78),~~

1 ~~entitled "An act authorizing political subdivisions,~~  
2 ~~municipality authorities and transportation authorities to enter~~  
3 ~~into contracts for the purchase of goods and the sale of real~~  
4 ~~and personal property where no bids are received," shall not be~~  
5 ~~made except with and from the lowest responsible and responsive~~  
6 ~~bidder meeting specifications, after due notice in at least one~~  
7 ~~newspaper of general circulation, published or circulating in~~  
8 ~~the county at least [three (3)] two (2) times, at intervals of~~  
9 ~~not less than three (3) days where daily newspapers of general~~  
10 ~~circulation are employed for such publication, or in case weekly~~  
11 ~~newspapers are employed, then the notice shall be published once~~  
12 ~~a week for two (2) successive weeks. The first advertisement~~

15 ~~(a.1) The requirements of this subsection need not be~~  
16 ~~followed in cases of emergency, but in such cases the actual~~  
17 ~~emergency shall be declared and stated by resolution of the~~

19 ~~(b) The acceptance of all bids shall be by the controller.~~  
20 ~~They shall be opened publicly at a time and place to be~~  
21 ~~designated in the notice. All the figures shall be announced~~  
22 ~~publicly by the chief clerk or his designee and referred to the~~  
23 ~~appropriate departments for tabulation without the presence of~~  
24 ~~the commissioners. Whenever, for any reason, the bid openings~~  
25 ~~shall not be held, the same business may be transacted at a~~  
26 ~~subsequent [time, if at least five (5) days notice thereof shall~~  
27 ~~be published in the newspaper aforesaid.] meeting, the time and~~

3 ~~may be made by the mutual written consent of the commissioners~~

5 ~~award. The commissioners shall excuse from consideration any~~  
6 ~~bidder not wishing to agree to a request for extension of the~~  
7 ~~date for the award and shall release such bidder from any bid~~  
8 ~~bond or similar bid security furnished under subsection (b.1).~~  
9 ~~All contracts shall be filed with the controller or with the~~  
10 ~~chief clerk, as the case may be, immediately after their~~  
11 ~~execution.~~

12 ~~(b.1) All bids [may] shall if required by the commissioners~~  
13 ~~be accompanied by cash [or by a certified good faith check], a~~  
14 ~~certified check, cashier's check, bank good faith check or~~  
15 ~~irrevocable letter of credit in a reasonable amount drawn upon a~~  
16 ~~bank authorized to do business in the Commonwealth[, in an~~  
17 ~~amount not exceeding five per centum (5%) of the bid] or by a~~  
18 ~~bond with corporate surety [not exceeding five per centum (5%)~~  
19 ~~of the amount bid] in a reasonable amount. In the event any~~  
20 ~~bidder shall, upon award of the contract to him, fail to comply~~  
21 ~~with the requirements hereinafter stated as to [a bond] security~~  
22 ~~guaranteeing the performance of the contract, or fail or refuse~~  
23 ~~to enter into a contract, or otherwise fail or refuse to render~~  
24 ~~the required services, the [good faith deposit by cash,~~  
25 ~~certified check or bond] security furnished under this~~  
26 ~~subsection shall be forfeited to the county as liquidated~~  
27 ~~damages, and the contract subsequently may be awarded to the~~  
28 ~~next lowest bidder, who shall manifest his acceptance of such~~

1 ~~the award of the contract to such bidder and otherwise comply~~

3 ~~(b.2) The amount or price of the contract shall, in all~~  
4 ~~cases whether of straight sale price, conditional sale, lease,~~  
5 ~~lease purchase or otherwise, be the entire amount which the~~  
6 ~~county pays to the successful bidder, or his assigns, plus the~~  
7 ~~value of personal property transferred from the county to the~~  
8 ~~bidder or his assigns at any time during the duration of the~~  
9 ~~contract, in order to obtain the services or property, or both,~~  
10 ~~and shall not be construed to mean only the amount which is paid~~  
11 ~~to acquire title or to receive any other particular benefit or~~  
12 ~~benefits of the whole bargain. The value of personal property~~  
13 ~~transferred to the bidder or his assigns upon execution of the~~  
14 ~~contract shall be specified in the bid. The method of~~  
15 ~~determining the value of personal property transferred to the~~  
16 ~~bidder or his assigns at a time during the duration of the~~  
17 ~~contract shall be specified in the bid and shall be determined~~  
18 ~~using generally accepted valuation methods.~~

19 ~~(c) The successful bidder, when [advertising] a formal bid~~  
20 ~~is required herein, shall be required to furnish a bond [with~~  
21 ~~suitable reasonable requirements] or irrevocable letter of~~  
22 ~~credit or other security in an amount sufficient to the~~  
23 ~~commissioners guaranteeing performance of the contract[, with~~  
24 ~~sufficient surety in the amount of fifty per centum (50%) of the~~  
25 ~~amount of the contract,] within thirty (30) days after the~~  
26 ~~contract has been awarded, unless the commissioners shall~~  
27 ~~prescribe a shorter period or unless the commissioners shall~~  
28 ~~waive the bond requirement in the bid specification. The~~  
29 ~~successful bidder for a contract which involves the~~  
30 ~~construction, erection, installation, completion, alteration,~~

1 ~~repair of or addition to any public work or improvement of any~~  
2 ~~kind shall furnish security as provided in section 2518.~~  
3 ~~Performance security for services and contracts for labor and~~  
4 ~~materials delivered on a periodic basis, including, but not~~  
5 ~~limited to, food service contracts, home health services and~~  
6 ~~janitorial services and supplies, may be computed on the~~  
7 ~~expected average value for one or more months at the discretion~~  
8 ~~of the commissioners.~~ Upon failure to furnish any required bond  
9 within such time, the previous awards shall be void and the  
10 commissioners may award the contract to the next lowest bidder.  
11 Deliveries, ~~performances,~~ accomplishment and guarantees may be  
12 required in all cases of expenditures, including the exceptions  
13 herein.

14 (d) ~~The contracts or purchases made by the commissioners~~  
15 ~~involving an expenditure of over ten thousand dollars (\$10,000)~~  
16 ~~which shall not require advertising or bidding as hereinbefore~~  
17 ~~provided are as follows:~~

18 (1) ~~Those for maintenance, repairs or replacements for~~  
19 ~~water, electric light, or other public works: Provided, That~~  
20 ~~they do not constitute new additions, extensions or enlargements~~  
21 ~~of existing facilities and equipment[, but a bond]. Security may~~  
22 ~~be required by the county commissioners as in other cases of~~  
23 ~~work done.~~

24 (2) ~~Those made for improvements, repairs and maintenance of~~  
25 ~~any kind made or provided by the county through its own~~  
26 ~~employees[: Provided, That this]. This paragraph shall not apply~~  
27 ~~to construction materials used in a street improvement.~~

28 (3) ~~Those where particular types, models or pieces of new~~  
29 ~~equipment, articles, apparatus, appliances, vehicles or parts~~  
30 ~~thereof are desired by the county commissioners, which are~~

1 ~~patented and manufactured products or copyrighted products.~~

2 ~~(4) Those involving any policies of insurance or surety~~  
3 ~~company bonds, those made for public utility service and~~  
4 ~~electricity, natural gas or telecommunication services:~~

5 ~~Provided, That, in the case of utilities not under tariffs on~~  
6 ~~file with the Pennsylvania Public Utility Commission[.]~~  
7 ~~contracts made without advertising and bidding shall be made~~  
8 ~~only after receiving written or telephonic price quotations from~~  
9 ~~at least three (3) qualified and responsible contractors or, in~~  
10 ~~lieu of price quotations, a memorandum shall be kept on file~~  
11 ~~showing that fewer than three (3) qualified contractors exist in~~  
12 ~~the market area within which it is practicable to obtain~~  
13 ~~quotations. A written record of telephonic price quotations~~  
14 ~~shall be made and contain at least the date of the quotation,~~  
15 ~~the name of the contractor and the contractor's representative.~~

16 ~~(5) Those involving personal or professional services[.]~~  
17 ~~including, but not limited to, services of members of the~~  
18 ~~medical or legal profession, registered architects, engineers,~~  
19 ~~certified public accountants or other personal services~~  
20 ~~involving professional expertise.~~

21 ~~(6) Those involving tangible client services provided by~~  
22 ~~nonprofit agencies. For the purposes of this clause, the term~~  
23 ~~"tangible client services" shall mean congregate meals, home-~~  
24 ~~delivered meals, transportation and chore services provided~~  
25 ~~through area agencies on aging.~~

26 ~~(6.1) Those involving contracts entered into by nonprofit~~  
27 ~~cooperative hospital service associations for hospitals and~~  
28 ~~nursing homes which are part of the institutional district or~~  
29 ~~which are owned by the county, operated by the county or~~  
30 ~~affiliated with the county by the purchasing of or participating~~



1 ~~in contracts for materials, supplies and equipment.~~

2 ~~(7) Those involving the purchase of milk.~~

3 ~~(8) Those made with any public body, including, but not~~  
4 ~~limited to, the sale, lease or loan of any supplies or materials~~  
5 ~~to the county by a public body, provided that the price thereof~~  
6 ~~shall not be in excess of that fixed by the public body. The~~  
7 ~~requirements of 53 Pa.C.S. Ch. 23 Subch. A (relating to~~  
8 ~~intergovernmental cooperation) shall not apply when a county~~  
9 ~~purchases cooperatively with another public body which has~~  
10 ~~entered into a contract for supplies or materials. As used in~~  
11 ~~this paragraph, "public body" shall mean any of the following:~~

12 ~~(i) the Federal Government;~~

13 ~~(ii) the Commonwealth of Pennsylvania;~~

14 ~~(iii) any other state;~~

15 ~~(iv) a political subdivision, local or municipal authority~~  
16 ~~or other similar local entity of the Commonwealth or any other~~

20 ~~(9) Those exclusively involving construction management~~  
21 ~~services.~~

22 ~~(10) Those involving computer software.~~

23 ~~(d.1) Notwithstanding the provisions of this article to the~~  
24 ~~contrary, the county commissioners shall have authority to enter~~  
25 ~~into contracts for equipment and services related to technology~~  
26 ~~and information systems on the basis of best value procurement.~~  
27 ~~Contracts under best value procurement shall be made only after~~  
28 ~~the county has solicited proposals based on performance and~~  
29 ~~outcome specifications developed by the county and describing at~~  
30 ~~minimum the objectives to be met by the system, the tasks to be~~

1 ~~performed by the system, the users of the system, system~~  
2 ~~security issues, the time frame for system implementation,~~  
3 ~~potential operating technologies, compatibility with existing~~  
4 ~~systems, training and maintenance and shall indicate the process~~  
5 ~~by which the contract shall be awarded. Best value procurement~~  
6 ~~shall not require a sealed bid process and shall permit the~~  
7 ~~commissioners to negotiate the terms of the agreement with any~~  
8 ~~responsive and responsible vendor.~~

9 ~~(c) [Every contract for the construction, reconstruction,~~  
10 ~~alteration, repair, improvement or maintenance of public works~~  
11 ~~shall comply with the provisions of the act of March 3, 1978~~  
12 ~~(P.L.6, No.3), known as the "Steel Products Procurement Act."]~~  
13 ~~Every contract subject to this article shall comply, as~~  
14 ~~applicable, with the provisions of:~~

15 ~~(1) The act of August 15, 1961 (P.L.987, No.442), known as~~  
16 ~~the "Pennsylvania Prevailing Wage Act."~~

17 ~~(2) The act of December 20, 1967 (P.L.869, No.385), known as~~  
18 ~~the "Public Works Contractors' Bond Law of 1967."~~

19 ~~(3) The act of January 23, 1974 (P.L.9, No.4), referred to~~  
20 ~~as the Public Contract Bid Withdrawal Law."~~

21 ~~(4) The act of March 3, 1978 (P.L.6, No.3), known as the~~  
22 ~~"Steel Products Procurement Act".~~

23 ~~(5) The act of February 17, 1994 (P.L.73, No.7), known as~~  
24 ~~the "Contractor and Subcontractor Payment Act."~~

25 ~~(6) 62 Pa.C.S. Chs. 37 Subch. B (relating to motor~~  
26 ~~vehicles), 39 (relating to contracts for public works) and 45~~  
27 ~~(relating to antibid rigging).~~

28 ~~(f) No person, consultant, firm or corporation contracting~~  
29 ~~with a county for purposes of rendering personal or professional~~  
30 ~~services to the county shall share with any county officer or~~

1 ~~employe, and no county officer or employe shall accept, any~~  
2 ~~portion of the compensation or fees paid by the county for the~~  
3 ~~contracted services provided to the county except under the~~  
4 ~~following terms or conditions:~~

5 ~~(1) Full disclosure of all relevant information regarding~~  
6 ~~the sharing of the compensation or fees shall be made to the~~  
7 ~~board of commissioners.~~

8 ~~(2) The board of commissioners must approve the sharing of~~  
9 ~~any fee or compensation for personal or professional services~~  
10 ~~prior to the performance of said services.~~

11 ~~(3) No fee or compensation for personal or professional~~  
12 ~~services may be shared except for work actually performed.~~

13 ~~(4) No shared fee or compensation for personal or~~  
14 ~~professional services may be paid at a rate in excess of that~~  
15 ~~commensurate for similar personal or professional services.~~

16 ~~(g) (1) The board of commissioners may, in its sole~~  
17 ~~discretion, elect to use an alternative contracting procedure to~~  
18 ~~achieve the adaptive reuse of former jail facilities. If the~~  
19 ~~board of commissioners elects to utilize an alternative~~  
20 ~~contracting procedure, the board shall adopt a resolution that~~  
21 ~~the use of an alternative contracting procedure is the most~~  
22 ~~efficient, economical and timely method to secure an adaptive~~  
23 ~~reuse of former jail facilities. Upon adoption of a resolution,~~  
24 ~~the board of commissioners shall request written proposals from~~  
25 ~~proposers for the adaptive reuse of former jail facilities under~~  
26 ~~an alternative contracting method. In its request for proposals,~~  
27 ~~the board shall include such terms, conditions and requirements~~  
28 ~~which it deems necessary to protect the interests of the county.~~

29 ~~(2) In reviewing and evaluating the proposals for the~~  
30 ~~adaptive reuse of former jail facilities, the board of~~

1 ~~commissioners shall, in addition to compliance with the terms,~~  
2 ~~conditions and requirements set forth in the request for~~  
3 ~~proposals, consider the following criteria:~~

4 ~~(i) the cost of the proposer's adaptive reuse proposal;~~

5 ~~(ii) experience of the proposer;~~

6 ~~(iii) preservation of the distinct architectural design and~~  
7 ~~integrity of the former jail facilities;~~

8 ~~(iv) adherence to prevailing wage laws and other work force~~  
9 ~~standards;~~

10 ~~(v) commitment to enter into voluntary contract with~~  
11 ~~disadvantaged business enterprises.~~

12 ~~After due consideration of proposals under the criteria~~  
13 ~~described above, the board of commissioners may, in its~~  
14 ~~discretion, select a proposal and award a contract to a~~  
15 ~~responsible proposer for the adaptive reuse of former jail~~  
16 ~~facilities under an alternative contracting procedure. The award~~  
17 ~~of a contract for the adaptive reuse of former jail facilities~~  
18 ~~need not be awarded to the lowest bidder.~~

19 ~~(3) Any contract for the adaptive reuse for former jail~~  
20 ~~facilities awarded under this subsection shall be exempt from~~  
21 ~~and not be subject to sections 2517 and 2520 of this act or the~~  
22 ~~act of May 1, 1913 (P.L.155, No.104), entitled "An act~~  
23 ~~regulating the letting of certain contracts for the erection,~~  
24 ~~construction, and alteration of public buildings."~~

25 ~~(4) As used in this section, the following words and phrases~~  
26 ~~shall have the meanings given to them in this subsection:~~

27 ~~"Adaptive reuse." The alteration, renovation, remodeling,~~  
28 ~~modification or reconstruction of former jail facilities for~~  
29 ~~reuse as courtrooms, office space or such other facilities and~~  
30 ~~uses as the board of commissioners shall from time to time deem~~

1 ~~necessary and appropriate.~~

2 ~~"Alternative contracting procedure."—A procedure under which~~  
3 ~~a proposer would be responsible for all aspects or phases~~  
4 ~~necessary to achieve the development of a parcel of property.~~  
5 ~~Such aspects or phases of development shall include, but not~~  
6 ~~necessarily be limited to, the planning, design, finance,~~  
7 ~~construction and management of property. The term "alternative~~  
8 ~~contracting procedure" shall be similar in all respects to the~~  
9 ~~commonly understood term in the real estate development and~~  
10 ~~construction industry known as a "turnkey."~~

11 ~~"Former jail facilities."—A building or group of buildings~~  
12 ~~with related facilities owned by a county of the second class~~  
13 ~~which are more than one hundred years old and which were~~  
14 ~~previously used as jail facilities.~~

15 ~~"Proposer."—A firm, organization or company or a combination~~  
16 ~~of firms, organizations or companies acting as a partnership,~~  
17 ~~joint venture, consortium or similar joint relationship with~~  
18 ~~sufficient knowledge, expertise and experience in the areas of~~  
19 ~~architectural design, construction, financing of real estate~~  
20 ~~development or construction and real estate management.~~

21 ~~Section 4.—Sections 2505(a) and 2506 of the act are amended~~  
22 ~~to read:~~

23 ~~Section 2505.—Acquiring and Using Real Property; [Court~~  
24 ~~Approval;] Exceptions.—(a) The county commissioners may~~  
25 ~~purchase for not more than fair market value, take by gift,~~  
26 ~~devise or by the power of eminent domain, in accordance with the~~  
27 ~~provisions of this act, such real property at the county seat or~~  
28 ~~in such other places, as may be authorized by law, as they deem~~  
29 ~~necessary for the purposes of a county courthouse, county jail,~~
