## AN ACT

- 1 Amending Title 62 (Procurement) of the Pennsylvania Consolidated
- 2 Statutes, providing for hardwood manufacturer and supplier
- 3 preferences.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Chapter 37 of Title 62 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a subchapter to read:
- 8 SUBCHAPTER F
- 9 HARDWOOD INTERIOR OFFICE FURNITURE

- 11 3761. Definitions.
- 12 3762. Preference.
- 13 § 3761. Definitions.
- 14 The following words and phrases when used in this subchapter
- 15 shall have the meanings given to them in this section unless the
- 16 context clearly indicates otherwise:
- 17 "Hardwood." Generally includes one of the botantical groups

- 1 of broadleaf trees in contrast to conifers or softwoods. The
- 2 term includes, but is not limited to, the following: northern
- 3 red oak, white oak, red maple, black cherry, hard maple, beech,
- 4 poplar, walnut, ash and hickory.
- 5 "Interior office furniture." Equipment that is necessary or
- 6 useful in day-to-day workings of an office including desks,
- 7 chairs, bookcases, credenzas, computer workstations, storage
- 8 cabinets or any component thereof.
- 9 "Purchasing agency." A Commonwealth agency authorized by
- 10 this title or by other law to enter into contracts for itself or
- 11 as the agent of another Commonwealth agency. When purchasing for
- 12 another Commonwealth agency, the purchasing agency acts on
- 13 behalf of the principal which needs the supplies, services and
- 14 construction and shall coordinate and cooperate with that
- 15 agency.
- 16 § 3762. Preference.
- 17 Any purchasing agency entering into a contract with a
- 18 supplier or manufacturer of hardwood interior office furniture
- 19 after the effective date of this subchapter shall, to the extent
- 20 possible, grant a bid preference equal to 25% of the total cost
- 21 of the interior office furniture to suppliers that supply
- 22 interior hardwood office furniture manufactured in Pennsylvania,
- 23 or to manufacturers that manufacture interior hardwood office
- 24 furniture in Pennsylvania. The preference shall be against any
- 25 other bid from suppliers that supply interior hardwood furniture
- 26 manufactured outside of Pennsylvania, or from manufacturers that
- 27 manufacture interior hardwood furniture outside of Pennsylvania.
- 28 Section 2. This act shall take effect in 60 days.
