AN ACT

Providing for the establishment of the Office of Community,
 Business and Education Partnerships and its powers and
 duties.

4 The General Assembly of the Commonwealth of Pennsylvania

5 hereby enacts as follows:

6 Section 1. Short title.

7 This act shall be known and may be cited as the Keystone

8 Community, Business and Education Partnership Act.

9 Section 2. Definitions.

10 The following words and phrases when used in this act shall

11 have the meanings given to them in this section unless the

12 context clearly indicates otherwise:

13 "Office." The Office of Community, Business and Education 14 Partnerships established by this act.

15 "Private sector." Any private business, corporation,

individual, trade association, foundation, federally or locally 1 supported grant program and other non-Commonwealth source 2 3 operating for profit or not-for-profit. 4 "School entity." A school district, intermediate unit, joint school or area vocational-technical school. 5 Section 3. Declaration of policy. 6 7 The General Assembly finds and declares as follows: 8 This Commonwealth's system of public education would (1)be strengthened by greater collaboration between the private 9 sector and school entities. 10 11 Where collaborative efforts presently exist, (2) schools, teachers, students and the community at large 12 13 benefit from the support, recognition and expertise provided 14 by the business community. 15 (3) Businesses benefit by helping to prepare a pool of 16 qualified potential employees. 17 (4) Communities benefit by having better schools which 18 enhance the quality of life, provide greater community 19 stability and improve the economic climate. 20 (5) There is presently no entity at the State level responsible for the collection and dissemination of 21 22 information regarding partnerships between the private sector 23 and school entities. Section 4. Office of Community, Business and Education 24 25 Partnerships. 26 (a) Establishment.--The Secretary of Education shall 27 establish the Office of Community, Business and Education 28 Partnerships within the Department of Education. 29 Purposes. -- The purposes of the office are to encourage (b) 30 and enhance partnerships between school entities and the private 20020H2359B3282

4 (c) Powers and duties.--The office shall have the following5 powers and duties:

6 (1) To develop recommendations for the establishment of 7 private sector partnerships with school entities.

8 (2) To establish a network for the exchange of expertise 9 and information about private sector and school entity 10 partnerships throughout this Commonwealth.

11 (3) To provide technical assistance and workshops to 12 facilitate the exchange of information and expertise about 13 partnership programs.

14 (4) To establish a method of assessing the impact of
15 private sector and school entity partnerships on improving
16 the quality of education.

17 (5) To identify exemplary partnership programs,
18 materials and models to be disseminated to school entities.

19 (6) To establish appropriate award programs to recognize
 20 businesses for their contributions to improving education and
 21 to recognize exemplary partnership programs.

(7) To prepare and submit an annual report to the
General Assembly and the Governor which includes the
following:

25 (i) A summary of the status of private sector and26 school entity partnership programs.

27 (ii) Recommendations to improve the efficiency and
28 promote the growth of private sector and school entity
29 partnerships.
