## AN ACT

- 1 Making appropriations to the Philadelphia Health and Education
- 2 Corporation for the MCP Hahnemann University and for
- 3 continuation of pediatric services.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. (a) The sum of \$7,735,000 is hereby appropriated
- 7 to the Philadelphia Health and Education Corporation for the MCP
- 8 Hahnemann University for the fiscal year July 1, 2002, to June
- 9 30, 2003, for instruction in the Doctor of Medicine program.
- 10 (b) The sum of \$1,708,000 is hereby appropriated to the
- 11 Philadelphia Health and Education Corporation for the MCP
- 12 Hahnemann University for the fiscal year July 1, 2002, to June
- 13 30, 2003, for the general maintenance of the MCP Hahnemann
- 14 University, including the Allied Health, Professions and
- 15 Graduate School of the MCP Hahnemann University, and student
- 16 aid.
- 17 (c) The sum of \$305,000 is hereby appropriated to the
- 18 Philadelphia Health and Education Corporation for the MCP

- 1 Hahnemann University for the fiscal year July 1, 2002, to June
- 2 30, 2003, for minority educational and recruitment programs.
- 3 (d) The sum of \$751,000 is hereby appropriated to the
- 4 Philadelphia Health and Education Corporation, for the fiscal
- 5 year July 1, 2002, to June 30, 2003, for continued pediatric
- 6 outpatient and inpatient treatment of severe physically
- 7 disabling diseases.
- 8 (e) The sum of \$158,000 is hereby appropriated to the
- 9 Philadelphia Health and Education Corporation, for the fiscal
- 10 year July 1, 2002, to June 30, 2003, for continued support of
- 11 the handicapped children's clinic.
- 12 (f) The sum of \$2,000,000 is hereby appropriated to the
- 13 Philadelphia Health and Education Corporation, for the MCP
- 14 Hahnemann University for the fiscal year July 1, 2002, to June
- 15 30, 2003, for operating expenses.
- 16 Section 2. (a) Payments to the Philadelphia Health and
- 17 Education Corporation for the MCP Hahnemann University on
- 18 account of the appropriations provided in section 1(a), (b), (c)
- 19 and (f) shall be made quarterly by the Secretary of Education on
- 20 the basis of costs during the fiscal year and shall be
- 21 conditioned on continuing authority for inclusion on the Board
- 22 of Trustees of the Philadelphia Health and Education Corporation
- 23 of a minimum of five persons who are not elected officials and
- 24 who are appointed by the Governor, the President pro tempore of
- 25 the Senate, the Minority Leader of the Senate, the Speaker of
- 26 the House of Representatives and the Minority Leader of the
- 27 House of Representatives for terms of office coterminous with
- 28 that of the respective appointing authority; and shall be
- 29 further conditioned on these appointees receiving full voting
- 30 rights as members of the board of trustees.

- 1 (b) Payments to the Philadelphia Health and Education
- 2 Corporation on account of the appropriations provided in section
- 3 1(d) and (e) shall be made by the Secretary of Health in equal
- 4 quarterly payments.
- 5 Section 3. (a) The Philadelphia Health and Education
- 6 Corporation for the MCP Hahnemann University shall provide full,
- 7 complete and accurate information for the appropriations under
- 8 section 1(a), (b), (c) and (f) as may be required by the
- 9 Department of Education or the chairman or the minority chairman
- 10 of the Appropriations Committee of the Senate or the chairman or
- 11 the minority chairman of the Appropriations Committee of the
- 12 House of Representatives.
- 13 (b) The Philadelphia Health and Education Corporation shall
- 14 provide full, complete and accurate information for the
- 15 appropriations under section 1(d) and (e) as may be required by
- 16 the Department of Health or the chairman or the minority
- 17 chairman of the Appropriations Committee of the Senate or the
- 18 chairman or the minority chairman of the Appropriations
- 19 Committee of the House of Representatives.
- 20 Section 4. The Philadelphia Health and Education Corporation
- 21 for the MCP Hahnemann University shall report its revenues and
- 22 expenditures and present its financial statements in accordance
- 23 with generally accepted accounting principles and procedures for
- 24 educational institutions as set forth in the "Higher Education
- 25 Finance Manual (1975)" and the "Commonwealth of Pennsylvania
- 26 Budget Instructions for the State System of Higher Education,
- 27 State-Related Universities and Non-State-Related Colleges and
- 28 Universities."
- 29 Section 5. The trustees of the Philadelphia Health and
- 30 Education Corporation for the MCP Hahnemann University shall

- 1 report on forms provided by the Department of Education to both
- 2 the chairman and minority chairman of the Appropriations
- 3 Committee of the Senate and the chairman and minority chairman
- 4 of the Appropriations Committee of the House of Representatives
- 5 by September 30, 2003, on how State-appropriated funds were
- 6 expended for fiscal year 2002-2003 to reduce the costs to
- 7 Pennsylvania resident students or to provide services to
- 8 Pennsylvania residents.
- 9 Section 6. This act shall take effect July 1, 2002, or
- 10 immediately, whichever is later.
