AS AMENDED ON THIRD CONSIDERATION, HOUSE OF REPRESENTATIVES,
APRIL 15, 2002

AN ACT

1 Apportioning this Commonwealth into congressional districts in
2 conformity with constitutional requirements; providing for
3 the nomination and election of Congressmen; and requiring
4 publication of notice of the establishment of congressional
5 districts following the Federal decennial census; imposing
6 duties on the Secretary of the Commonwealth and the
7 Legislative Reference Bureau; and making a repeal.

8 The General Assembly of the Commonwealth of Pennsylvania
9 hereby enacts as follows:

10 Section 1. Congressional districts.

11 For the purpose of electing representatives of the people of
12 Pennsylvania to serve in the House of Representatives in the
13 Congress of the United States, this Commonwealth shall be
14 divided into 19 districts which shall have one Congressman each,

27 AND SOUTH HUNTINGDON, UNITY DISTRICTS BAGGALEY, BEATTY,

5 (19) THE NINETEENTH DISTRICT IS COMPOSED OF ALL OF ADAMS
6 COUNTY; PART OF CUMBERLAND COUNTY CONSISTING OF THE TOWNSHIPS
7 OF DICKINSON PRECINCT SOUTH, EAST PENNSBORO, HAMPDEN, LOWER
8 ALLEN, MIDDLESEX PRECINCT 2, MONROE, SHIPPENSBURG, SILVER
9 SPRING, SOUTH MIDDLETON, SOUTHAMPTON DISTRICT UPPER (DIVISION
10 2), UPPER ALLEN AND WEST PENNSBORO PRECINCT LOWER AND THE
11 BOROUGHES OF CAMP HILL, CARLISLE, LEMOYNE, MECHANICSBURG,
12 MOUNT HOLLY SPRINGS, NEW CUMBERLAND, SHIPPENSBURG (CUMBERLAND
13 COUNTY PORTION), SHIREMANSTOWN AND WORMLEYSBURG; AND ALL OF
14 YORK COUNTY.

15 Section 2. First election.

16 (a) General rule.--The first election under this act shall
17 be held at the primary election in the year 2002.

18 (b) Current officeholders.--The members of Congress now in
19 office shall continue in the office until the expiration of
20 their respective terms.

21 (c) Vacancies.--Vacancies now existing or happening after
22 the passage of this act and before the commencement of the terms
23 of the members elected at the election of 2002 shall be filled
24 for the unexpired terms from the districts formerly prescribed
25 by law.

26 Section 3. Missed political subdivision.

27 In the event any political subdivision or part thereof should
28 be omitted in the description of the congressional districts,
29 the political subdivision or part thereof shall be included as a
30 part of the congressional district which completely surrounds

1 it. Should any omitted political subdivision or part thereof be
2 not completely surrounded by one congressional district, it
3 shall become a part of that congressional district to which it
4 is contiguous, or if there are two or more such contiguous
5 districts, it shall become a part of that congressional district
6 contiguous thereto which has the least population.

7 Section 4. Duty to publish notice of redistricting.

8 Upon the enactment of this act providing for the
9 establishment of congressional districts following the official
10 reporting of the Federal decennial census as required by Federal
11 law, the Secretary of the Commonwealth shall publish notice of
12 the congressional districts as established at least once in at
13 least one newspaper of general circulation in each county in
14 which such newspapers are published.

15 Section 5. Contents of notice.

16 The notice shall contain a map of this Commonwealth showing
17 all congressional districts established and a map showing the
18 congressional districts in the county in which the publication
19 is made. The notice shall also state the population of the
20 districts having the smallest and largest populations and the
21 percentage variation of such districts from the average
22 population for congressional districts.

23 Section 6. Repeals and abrogation.

24 (a) Statutes.--

25 (1) The act of January 7, 2002 (P.L.1, No.1), entitled
26 "An act to apportion the Commonwealth of Pennsylvania into
27 congressional districts in conformity with constitutional
28 requirements; providing for the nomination and election of
29 Congressmen; and requiring publication of notice of the
30 establishment of congressional districts following the

1 Federal decennial census," is repealed.

2 (2) All other acts and parts of acts are repealed
3 insofar as they are inconsistent with this act.

4 (b) Existing plan.--The existing State Congressional
5 Redistricting Plan is abrogated.

6 Section 7. Pending litigation.

7 If the Secretary of the Commonwealth determines that Federal
8 litigation over the validity of the congressional apportionment
9 under the act of January 7, 2002 (P.L.1, No.1), entitled "An act
10 to apportion the Commonwealth of Pennsylvania into congressional
11 districts in conformity with constitutional requirements;
12 providing for the nomination and election of Congressmen; and
13 requiring publication of notice of the establishment of
14 congressional districts following the Federal decennial census,"
15 has been finally resolved with a judicial declaration of
16 invalidity, the secretary shall transmit notice of the
17 determination to the Legislative Reference Bureau for
18 publication in the Pennsylvania Bulletin.

19 Section 8. Effective date.

20 This act shall take effect as follows:

21 (1) Section 6(b) shall take effect November 6, 2002.

22 (2) The following provisions shall take effect
23 immediately:

24 (i) Section 7.

25 (ii) This section.

26 (3) The remainder of this act shall take effect upon
27 publication of the notice under section 7.
