## AN ACT

- 1 Authorizing the Department of General Services, with the
- 2 approval of the Department of Public Welfare and the
- 3 Governor, to grant and convey to the Society for the
- 4 Prevention of Cruelty to Animals of Chester County, Inc.,
- 5 certain land situate in West Bradford Township, Chester
- 6 County.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. West Bradford Township, Chester County Conveyance.
- 10 (a) Conveyance authorized. -- The Department of General
- 11 Services, with the approval of the Department of Public Welfare
- 12 and the Governor, is hereby authorized on behalf of the
- 13 Commonwealth of Pennsylvania to grant and convey to the Society
- 14 for the Prevention of Cruelty to Animals of Chester County, Inc.
- 15 certain land as described in subsection (b) for fair market
- 16 value as determined by an independent appraisal.
- 17 (b) Property description. -- The tract to be conveyed is
- 18 situate in the Township of West Bradford, Chester County,
- 19 Pennsylvania, bounded and described as follows:

- 1 ALL THAT CERTAIN tract or parcel of land situate in West
- 2 Bradford Township, Chester County, PA, described according to a
- 3 plan prepared by Regester Associates, Inc., dated March 12,
- 4 2002, and last revised May 13, 2002, being Drawing Number C-915,
- 5 to wit:
- 6 BEGINNING at a point in the title line of Public Road S.R.
- 7 3062 known as Strasburg Road, marking a corner of the herein
- 8 described tract and a corner of lands of the Tattersall Golf
- 9 Community; thence leaving the said point of beginning, leaving
- 10 Strasburg Road and along lands of the Tattersall Golf Community
- 11 the following three courses and distances to wit: South 02
- 12 degrees 58 minutes 05 seconds East 243.59 feet to a re-rod;
- 13 South 43 degrees 29 minutes 16 seconds East 248.53 feet to an
- 14 iron pin; South 28 degrees 12 minutes 17 seconds East 437.96
- 15 feet to an iron pin marking a corner of lands of the
- 16 Commonwealth of Pennsylvania; thence along the same the
- 17 following two courses and distances to wit; South 44 degrees 28
- 18 minutes 27 seconds West 1050.95 feet to an iron pin; North 09
- 19 degrees 27 minutes 18 seconds West 1523.20 feet to a point in
- 20 the title line of Strasburg Road, aforementioned; thence along
- 21 the same, North 84 degrees 32 minutes 27 seconds East 598.58
- 22 feet to the first mentioned point and place of BEGINNING.
- 23 CONTAINING: 20.000 acres of land be the same more or less.
- 24 (c) Conditions.--The conveyance shall be made under the
- 25 subject to all lawful and enforceable easements, servitudes and
- 26 rights of others, including, but not confined to, streets,
- 27 roadways and rights of telephone, telegraph, cable, water,
- 28 electric, sewer, gas or pipeline companies, as well as under the
- 29 subject to any lawful and enforceable estates or tenancies
- 30 vested in third persons appearing of record, for any portion of

- 1 the land or improvements erected thereon.
- 2 (d) Deed of conveyance. -- The deed of conveyance shall be by
- 3 Special Warranty Deed and shall be executed by the Secretary of
- 4 General Services in the name of the Commonwealth of
- 5 Pennsylvania.
- 6 (e) Special condition. -- The conveyance shall be subject to a
- 7 condition that the lands conveyed under this section shall be
- 8 used for the principal use of programs and services associated
- 9 with the prevention of cruelty to animals and enforcement of the
- 10 animal cruelty laws of the Commonwealth, by the grantee, or its
- 11 successor in interest. This condition may be removed by the
- 12 Commonwealth but only if the grantee demonstrates good reason to
- 13 do so and pays the Commonwealth an amount which represents the
- 14 difference in real dollars between the consideration paid by
- 15 grantee to the Commonwealth for the purchase of lands conveyed
- 16 in this section with the restrictive covenant and the then
- 17 current fair market appraised value of the property would have
- 18 had without the restrictive covenant. Should the grantee, while
- 19 this condition remains in effect;, either allow the property to <

- 20 be used for a principal use other than that described above or
- 21 attempts ATTEMPT to convey the premises, title shall immediately <-
- 22 revert to and revest in the Commonwealth.
- 23 (f) Costs and fees.--Costs and fees incidental to this
- 24 conveyance shall be borne by the grantee.
- 25 Section 2. Effective date.
- 26 This act shall take effect immediately.
