A RESOLUTION

- Designating the month of September 2002 as "Prostate Cancer
 Awareness Month" in Pennsylvania.
- 3 WHEREAS, Cancer of the prostate is, with the exception of
- 4 skin cancer, the most common type of cancer among American men
- 5 and is the second leading cause of cancer death among them; and
- 6 WHEREAS, The Pennsylvania Department of Health reports that
- 7 each year there are about 10,000 new prostate cancer cases
- 8 diagnosed among men in this Commonwealth and nearly 2,000
- 9 Pennsylvania men die from the disease; and
- 10 WHEREAS, The risk of developing prostate cancer increases
- 11 with age, as evidenced by the fact that 75% of men with new

- 1 diagnoses of prostate cancer are over 65 years of age; and
- WHEREAS, Prostate cancer is twice as common among African-
- 3 American men; and
- 4 WHEREAS, Early detection and screening for prostate cancer
- 5 are vital to combating the disease, especially for all men over
- 6 50 years of age, African-American men and men with a family
- 7 history of prostate cancer; and
- 8 WHEREAS, With early detection, the five-year relative
- 9 survival rate for men with localized prostate cancer is 100%;
- 10 and
- 11 WHEREAS, Greater public awareness and education about
- 12 prostate cancer is necessary to help protect the health and
- 13 welfare of men; therefore be it
- 14 RESOLVED, That the House of Representatives designate
- 15 September 2002 as "Prostate Cancer Awareness Month" in
- 16 Pennsylvania and encourage all men to educate themselves about
- 17 the risk of prostate cancer.
