## AN ACT

- 1 Establishing an educational assistance program for volunteer
- 2 firefighters; providing for grants; and making an
- 3 appropriation.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Educational
- 8 Assistance Program for Active Certified Volunteer Firefighters
- 9 Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Agency." The Pennsylvania Higher Education Assistance
- 15 Agency.
- 16 "Applicant." An active member of a volunteer fire company.
- 17 The Pennsylvania Higher Education Assistance Agency shall
- 18 determine whether the member is an active member of a volunteer

- 1 fire company. Active volunteer firefighter status may be
- 2 evidenced by acceptable documentation as determined by the
- 3 agency, including documentation provided by a representative.
- 4 "Approved institution of higher learning." An educational
- 5 institution offering a postsecondary program of education
- 6 located in this Commonwealth and approved by the Pennsylvania
- 7 Higher Education Assistance Agency.
- 8 "Approved program of education." A degree-granting or
- 9 certificate-granting curriculum or course of study pursued at an
- 10 approved institution of higher learning on a full-time or part-
- 11 time basis or its equivalent as determined by the Pennsylvania
- 12 Higher Education Assistance Agency.
- "Commissioner." The Pennsylvania State Fire Commissioner.
- 14 "Full-time student." A student enrolled in an approved
- 15 institution of higher learning pursuing an approved program of
- 16 education equal or greater than 15 credit hours or its
- 17 equivalent recognized by the Pennsylvania Higher Education
- 18 Assistance Agency as a full-time course of study.
- 19 "Part-time student." A student enrolled in an approved
- 20 institution of higher learning pursuing an approved program of
- 21 education of less than 15 credit hours or its equivalent
- 22 recognized by the Pennsylvania Higher Education Assistance
- 23 Agency as a part-time course of study.
- 24 "Professional certification program." The program operated
- 25 by the Office of State Fire Commissioner for the certification
- 26 of firefighters.
- 27 "Program." The Educational Assistance Program established in
- 28 this act.
- 29 "Qualified resident." An individual who has been a bona fide
- 30 resident of this Commonwealth for a period of at least 12

- 1 consecutive months immediately prior to the time an application
- 2 for a grant is made. The Pennsylvania Higher Education
- 3 Assistance Agency shall determine whether an applicant is a
- 4 qualified resident.
- 5 "Representative." The fire chief or president of a volunteer
- 6 fire company.
- 7 "Volunteer fire company." A nonprofit, chartered
- 8 corporation, association or organization located in this
- 9 Commonwealth which provides fire protection services within this
- 10 Commonwealth.
- 11 Section 3. Educational Assistance Program.
- 12 (a) Purpose. -- An Educational Assistance Program is hereby
- 13 established to provide grants to applicants for the purpose of
- 14 pursuing approved programs of education. Applicants shall be
- 15 entered into the program upon the receipt of their first grant
- 16 under subsection (b) or (c) and shall remain in the program for
- 17 the duration of their enrollment in an approved program of
- 18 education, but in no event shall they remain in the program for
- 19 a period exceeding five academic years or their equivalent, as
- 20 determined by the agency unless the agency determines that the
- 21 period of membership should be extended due to the applicant's
- 22 injury due to disability incurred in the line of duty.
- 23 (b) Criteria for part-time student assistance grants.--An
- 24 applicant is eligible to receive a part-time student assistance
- 25 grant pursuant to this act if the applicant meets all of the
- 26 following:
- 27 (1) Is a qualified resident of this Commonwealth.
- 28 (2) Has received a certificate of eligibility pursuant
- 29 to section 4.
- 30 (3) Has enrolled as a part-time student in an approved

- 1 program of education at an approved institution of higher
- 2 learning.
- 3 (4) Accepts an obligation to serve in a volunteer fire
- 4 company for a period of at least six years from the date of
- 5 entry into the program.
- 6 (c) Criteria for full-time student assistance grants.--An
- 7 applicant is eligible to receive a full-time student assistance
- 8 grant pursuant to this act if the applicant meets all of the
- 9 following:
- 10 (1) Is a qualified resident of this Commonwealth.
- 11 (2) Has received a certificate of eligibility pursuant
- 12 to section 4.
- 13 (3) Has enrolled as a full-time student in an approved
- 14 program of education at an approved institution of higher
- 15 learning.
- 16 (4) Accepts an obligation to serve in a volunteer fire
- 17 company for a period of at least six years from the date of
- 18 entry into the program.
- 19 (5) Does not possess a baccalaureate degree.
- 20 (d) Information required annually.--In order for an
- 21 applicant to receive a grant for each academic year in which the
- 22 applicant is a member of the program, an applicant shall
- 23 annually, in addition to meeting the requirements of this act,
- 24 provide such information as the agency, by regulation, deems
- 25 necessary.
- 26 Section 4. Certification of eligibility.
- 27 The commissioner shall verify to the agency that an applicant
- 28 has received certification from the Professional Certification
- 29 Program and shall provide the agency with a certificate of
- 30 eligibility for the applicant.

- 1 Section 5. Grant amounts.
- 2 (a) Part-time student assistance grants.--Grants awarded
- 3 pursuant to this act to part-time students shall be determined
- 4 by the agency without regard to financial need and shall not
- 5 exceed for each academic year or period the lesser of:
- 6 (1) one-half the tuition of the part-time course of
- 7 study in which the part-time student is enrolled; or
- 8 (2) one-half the tuition charged to a resident of this
- 9 Commonwealth at a member institution of the State System of
- 10 Higher Education for the same academic year or period.
- 11 (b) Full-time student assistance grants.--Grants awarded
- 12 pursuant to this act to full-time students shall be determined
- 13 by the agency without regard to financial need and shall not
- 14 exceed for each academic year or period the lesser of:
- 15 (1) the tuition of the approved institution of higher
- 16 learning for the approved program of education in which the
- 17 full-time student is enrolled; or
- 18 (2) the tuition charged to a resident of this
- 19 Commonwealth at a member institution of the State System of
- 20 Higher Education for the same academic year or period.
- 21 (c) Promissory notes. -- At the time of receipt of the grant,
- 22 a part-time or full-time student shall sign a promissory note to
- 23 repay the full amount of the grant if the requirements of the
- 24 program are not fulfilled.
- 25 (d) Other grants.--The agency shall not reduce the amount of
- 26 other agency grants or aid for which the applicant qualifies on
- 27 account of the applicant's eligibility for or receipt of grants
- 28 pursuant to this act.
- 29 (e) Adjustments.--If the agency determines that the amount
- 30 appropriated for the program in any year will be insufficient to

- 1 provide grants in the amounts set forth in this section to all
- 2 applicants, the agency may reduce the maximum amount of the
- 3 grants proportionately or set a limit on the number of
- 4 participants to ensure that sums expended do not exceed
- 5 appropriations.
- 6 Section 6. Limitations.
- 7 (a) Time.--No applicant shall be eligible for part-time or
- 8 full-time student assistance grants or a combination thereof
- 9 pursuant to this act for a total of more than five academic
- 10 years or their equivalent as determined by the agency.
- 11 (b) Required active status. -- No grant payments shall be made
- 12 pursuant to this act except during the applicant's service as an
- 13 active member of a volunteer fire company.
- 14 Section 7. Requirements.
- 15 (a) Liability.--An applicant who has received a grant shall
- 16 be required to remain on active service with a volunteer fire
- 17 company for a period of at least six years from the date of
- 18 entry into the program and remain enrolled as a part-time or
- 19 full-time student with respect to the type of grant they
- 20 initially received. An applicant who has received a grant and
- 21 fails to meet these requirements shall be liable to the
- 22 Commonwealth for repayment of all grant payments made.
- 23 (b) Review.--The agency shall determine whether an applicant
- 24 has complied with the requirements of this act.
- 25 (c) Forgiveness of recoupment. -- The agency may forgive
- 26 recoupment of all or part of an applicant's grant payments if
- 27 the agency determines that the applicant's failure to fulfill
- 28 the six-year service obligation was the result of the
- 29 applicant's death or injury due to disability incurred in the
- 30 line of duty.

- 1 Section 8. Regulations.
- 2 The agency shall promulgate regulations to administer the
- 3 provisions of this act.
- 4 Section 9. Appropriation.
- 5 The sum of \$5,000,000 is hereby appropriated to the
- 6 Pennsylvania Higher Education Assistance Agency from the General
- 7 Fund for the purpose of issuing part-time and full-time student
- 8 assistance grants. A portion of the funds appropriated may be
- 9 used to pay the costs of the administration of this act. Sources
- 10 of the grants shall be appropriations. Administrative costs for
- 11 the 2001-2002 fiscal year shall not exceed 5% of the total
- 12 amount of funds appropriated. Administrative costs in subsequent
- 13 years shall not exceed 4% of the total amount of funds
- 14 appropriated and shall be based on the processing fee for the
- 15 total number of applications.
- 16 Section 10. Effective date.
- 17 This act shall take effect in 60 days.
