## SENATE BILL No. 1169 Session of 2001

INTRODUCED BY D. WHITE, OCTOBER 19, 2001

AS AMENDED ON THIRD CONSIDERATION, DECEMBER 3, 2001

## AN ACT

Authorizing the Department of General Services, with the 2 approval of the Governor, to grant and convey to Indiana County, certain lands situate in the Borough of Indiana, 3 4 Indiana County. 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 The Department of General Services, with the approval of the Governor, is hereby authorized on behalf of the Commonwealth of Pennsylvania to grant and convey TO Indiana 10 County certain land and buildings A BUILDING described in 11 section 2 for fair consideration equal to fair market value as 12 determined by independent appraisal in accordance with an 13 Agreement of Sale to be executed with the Department of General 14 Services. 15 Section 2. The property to be conveyed pursuant to section 1 16 consists of approximately 0.88-acres and a building bounded and 17 more particularly described as follows:

BEGINNING at an iron pin 37.5 feet from the centerline of

- 1 North 4th Street; thence along the lands now or formerly of the
- 2 Commonwealth of Pennsylvania, North 89 degrees 38 minutes 01.2
- 3 seconds West 228.46 feet to a point; thence North 00 degrees 52
- 4 minutes 00 seconds East 165.65 feet to a point; thence North 89
- 5 degrees 12 minutes 00 seconds East 228.54 feet to a point;
- 6 thence South 00 degrees 52 minutes 00 seconds West 170.30 feet
- 7 to a point the place of BEGINNING.
- 8 CONTAINING 0.88-acres, more or less.
- 9 Section 3. The conveyance shall be made under and subject to
- 10 all lawful and enforceable easements, servitudes and rights of
- 11 others, including but not confined to streets, roadways and
- 12 rights of any telephone, telegraph, water, electric, gas or
- 13 pipeline companies, as well as under and subject to any lawful
- 14 and enforceable estates or tenancies vested in third persons
- 15 appearing of record, for any portion of the land or improvements
- 16 erected thereon.
- 17 Section 4. The deed of conveyance shall be by Special
- 18 Warranty Deed and shall be executed by the Secretary of General
- 19 Services in the name of the Commonwealth of Pennsylvania.
- 20 Section 5. Costs and fees incidental to this conveyance
- 21 shall be borne by the Grantee.
- 22 Section 6. In the event that this conveyance is not executed
- 23 in accordance with the Agreement of Sale as referenced in
- 24 section 1, the property may be disposed of in accordance with
- 25 Article 2406-A of the act of April 9, 1929 (P.L.177, No.175),
- 26 known as The Administrative Code of 1929.
- 27 Section 7. This act shall take effect immediately.
