10 THE NOMINATION AND ELECTION OF CONGRESSMEN; REQUIRING  
11 PUBLICATION OF NOTICE OF THE ESTABLISHMENT OF CONGRESSIONAL  
12 DISTRICTS FOLLOWING THE FEDERAL DECENNIAL CENSUS; PROVIDING

28 (B) GENERAL.--ALL OTHER ACTS AND PARTS OF ACTS ARE REPEALED  
29 INSOFAR AS THEY ARE INCONSISTENT WITH THIS ACT.

30 (C) PREVIOUSLY UTILIZED PLAN.--EXCEPT TO THE EXTENT

1 NECESSARY FOR AN ELECTION TO FILL A VACANCY UNDER SECTION  
2 302(B), THE STATE CONGRESSIONAL REDISTRICTING PLAN UTILIZED  
3 PRIOR TO JANUARY 7, 2002, IS ABROGATED.

4 SECTION 1503. SEVERABILITY.

5 THE PROVISIONS OF THIS ACT ARE SEVERABLE. IF ANY PROVISION OF  
6 THIS ACT OR ITS APPLICATION TO ANY PERSON OR CIRCUMSTANCE IS  
7 HELD INVALID, THE INVALIDITY SHALL NOT AFFECT OTHER PROVISIONS  
8 OR APPLICATIONS OF THIS ACT WHICH CAN BE GIVEN EFFECT WITHOUT  
9 THE INVALID PROVISION OR APPLICATION.

10 SECTION 1504. EFFECTIVE DATE.

11 THIS ACT SHALL TAKE EFFECT AS FOLLOWS:

23 (3) THE REMAINDER OF THIS ACT SHALL TAKE EFFECT  
24 IMMEDIATELY.

25 (4) NEITHER PARAGRAPH (3) NOR 1 PA.C.S. § 1701(B)(2)  
26 SHALL APPLY TO SECTIONS 501, 1501 OR 1502(B). IF A NOTICE IS  
27 NOT PUBLISHED UNDER SECTION 502(3), SECTIONS 501, 1501 AND  
28 1502(B) SHALL NOT TAKE EFFECT.
