AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, providing for the term of
- 3 jury duty; and further providing for the selection of
- 4 prospective jurors and their compensation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 42 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 4504. Term of jury duty.
- The length of the term of jury duty shall be one day, except
- 11 that if a juror is impaneled on a jury trial which lasts more
- 12 than one day, the term of jury duty shall be the length of that
- 13 trial.
- 14 Section 2. Sections 4521(a) and 4561(a) of Title 42 are
- 15 amended to read:
- 16 § 4521. Selection of prospective jurors.
- 17 (a) Preparation of master list of prospective jurors. -- At
- 18 least annually the jury selection commission shall prepare a

- 1 master list of prospective jurors. The list shall contain all
- 2 voter registration lists for the county, which lists may be
- 3 incorporated by reference, or names from such other lists which
- 4 in the opinion of the commission will provide a number of names
- 5 of prospective jurors which is equal to or greater than the
- 6 number of names contained in the voter registration list. The
- 7 commission [may, but will not be required to,] shall supplement
- 8 the master list of prospective jurors [to include, without being
- 9 limited to,] by including persons in any of the following
- 10 categories:
- 11 (1) Persons listed in telephone, city, municipal
- 12 directories and similar directories.
- 13 (2) Persons who pay taxes or are assessed for taxes
- imposed by any political subdivisions.
- 15 (3) Persons in the county participating in any State,
- 16 county or local program authorized by law and, to the extent
- such names are available, persons participating in any
- 18 Federal program authorized by law.
- 19 (4) Persons who are on school census lists.
- 20 (5) Any other person whose name does not appear in the
- 21 master list of prospective jurors and who meets the
- 22 qualifications for jurors set forth in this chapter and who
- 23 makes application to the commission to be listed on the
- 24 master list of prospective jurors.
- 25 * * *
- 26 § 4561. Compensation of and travel allowance for jurors.
- 27 (a) Compensation. -- A person summoned to serve as a juror
- 28 shall receive compensation at the rate of [\$9] \$25 a day for the
- 29 first three days in any calendar year he shall be required to
- 30 report for service and [\$25] <u>\$40</u> a day for each day thereafter

- 1 in such calendar year that such person is required to report. In
- 2 addition, persons so summoned shall be paid a travel allowance
- 3 at the rate of 17¢ per mile circular except that no travel
- 4 allowance shall be paid in the first judicial district.

- 6 Section 3. Section 4563(a) of Title 42 is amended and the
- 7 section is amended by adding a subsection to read:
- 8 § 4563. Protection of employment of petit and grand jurors.
- 9 (a) General rule. -- An employer shall not deprive an employee
- 10 of his employment, seniority position or benefits, or threaten
- 11 or otherwise coerce him with respect thereto, because the
- 12 employee receives a summons, responds thereto, serves as a juror
- 13 or attends court for prospective jury service. [Nothing in this
- 14 section shall be construed to require the employer to compensate
- 15 the employee for employment time lost because of such jury
- 16 service.]
- 17 * * *
- 18 (f) Full compensation.--
- 19 <u>(1) An employee shall be entitled to receive full</u>
- 20 compensation from his employer, less any compensation and
- 21 <u>travel allowance that he receives from serving as a juror</u>
- 22 under section 4561(a) (relating to compensation of and travel
- 23 <u>allowance for jurors), for not more than five days of jury</u>
- 24 service.
- 25 (2) An employer may compensate the employee for
- 26 employment time lost due to jury service beyond five days and
- 27 may require the employee to submit proof of total
- 28 <u>compensation and travel allowance paid to the employee while</u>
- 29 <u>serving as a juror.</u>
- 30 (3) This subsection shall apply only to employers who

- 1 employ 31 or more employees.
- 2 Section 4. This act shall take effect in 60 days.
