## AN ACT

- Providing for open contracting by the Commonwealth and its 2
- political subdivisions and their agencies and authorities.
- The General Assembly of the Commonwealth of Pennsylvania 3
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Open
- Contracting Act.
- Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Public body." The Commonwealth or any of its political
- subdivisions, or an agency or authority of either. 13
- "Public works." Construction, reconstruction, demolition, 14
- 15 alteration or repair work, other than routine maintenance work,

- 1 contracted for by a public body.
- 2 "Responsible bidder." A person, partnership or corporation
- 3 that has the capability in all respects to fully perform the
- 4 contract requirements and who has the integrity and reliability
- 5 which will assure good faith performance.
- 6 Section 3. Prohibited practices.
- 7 Contract specifications issued by public bodies soliciting
- 8 bids on public works projects shall not include any of the
- 9 following:
- 10 (1) A requirement that a successful bidder or any of its
- 11 subcontractors utilize workers:
- 12 (i) represented by a designated labor organization;
- 13 or
- 14 (ii) referred by a designated labor organization.
- 15 (2) A requirement that a successful bidder's existing
- work force or any of its subcontractors' work forces
- affiliate with or pay dues to a labor organization.
- 18 (3) A requirement that a successful bidder or any of its
- 19 subcontractors recognize a labor organization as the
- 20 exclusive representative of any of its employees on the
- 21 public works project.
- 22 Section 4. Discrimination prohibited.
- 23 It shall be an unlawful practice for a public body to
- 24 consider or use as a criterion in its selection process the
- 25 union or nonunion status of a bidder's work force.
- 26 Section 5. Enforcement.
- 27 (a) General rule. -- A party which is aggrieved by an act
- 28 committed by a public body which violates section 3 or 4 may
- 29 file an action in a court of competent jurisdiction to enjoin
- 30 the act.

- 1 (b) Damages and attorney fees.--A court of competent
- jurisdiction may award damages and reasonable attorney fees to 2
- an aggrieved party that is successful in an action filed under 3
- 4 subsection (a).
- 5 Section 6. Effective date.
- This act shall take effect in 60 days. 6
