AN ACT

- 1 Establishing the Science Technology Partnership Program; and 2 providing for State grants.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Science
- 7 Technology Partnership Act.
- 8 Section 2. Definitions.
- 9 The following words and phrases when used in this act shall
- 10 have the meanings given to them in this section unless the
- 11 context clearly indicates otherwise:
- 12 "Department." The Department of Education of the
- 13 Commonwealth.
- 14 "Higher education institution." Any public or private two-
- 15 year or four-year or higher postsecondary institution in this
- 16 Commonwealth that has been accredited at the college level by an

- 1 accrediting agency recognized by the Federal Secretary of
- 2 Education.
- 3 "NONPUBLIC SCHOOL." A NONPUBLIC KINDERGARTEN, ELEMENTARY
- 4 SCHOOL OR SECONDARY SCHOOL AT WHICH THE COMPULSORY ATTENDANCE
- 5 REQUIREMENTS OF THE COMMONWEALTH MAY BE MET AND WHICH MEETS THE

- 6 APPLICABLE REQUIREMENTS OF TITLE VI OF THE CIVIL RIGHTS ACT OF
- 7 1964 (PUBLIC LAW 88-352, 78 STAT. 241).
- 8 "Partnership." A science technology partnership established
- 9 under section 4.
- 10 "Program." The Science Technology Partnership Program
- 11 established in section 3.
- 12 "Public school." Any school owned or operated by a public
- 13 school district established under the act of March 10, 1949
- 14 (P.L.30, No.14), known as the Public School Code of 1949,
- 15 including any school established pursuant to Article XVII-A of
- 16 the Public School Code of 1949.
- 17 "Scientific or technical equipment." Technical or electronic
- 18 equipment used in teaching science courses, including laboratory
- 19 equipment. The equipment may include equipment that is not
- 20 routinely used in the teaching of science but that is commonly
- 21 used in the workplace and the fields of health, environment,
- 22 scientific research, biology, chemistry, geology or other earth
- 23 sciences, physics or any other scientific field.
- "Secretary." The Secretary of Education of the Commonwealth.
- 25 Section 3. Science Technology Partnership Program.
- 26 (a) Establishment.--The Science Technology Partnership
- 27 Program is hereby established. The purpose of the program shall
- 28 be to improve science education in public schools and school
- 29 districts AND NONPUBLIC SCHOOLS that are members of science
- 30 technology partnerships by:

- 1 (1) Making scientific or technical equipment available 2 to students.
- 3 (2) Augmenting the science curriculum.
- 4 (3) Providing additional professional development
- 5 opportunities to educators in the sciences.
- 6 (b) Administration. -- The department shall administer a grant
- 7 program that awards grants to qualified higher education
- 8 institutions that are members of the science technology
- 9 partnerships.
- 10 (c) Criteria for funding. -- To implement the program, the
- 11 department shall request proposals from higher education
- 12 institutions that are members of science technology partnerships
- 13 and may award grants to such institutions that meet all of the
- 14 following criteria:
- 15 (1) Have established a partnership as defined in section
- 4 and provided a copy of the partnership agreement to the
- department.
- 18 (2) Demonstrate how the partnership will make science
- 19 technology equipment available to students enrolled in public

- 20 AND NONPUBLIC schools that are partnership members.
- 21 (3) Demonstrate how the partnership will augment the
- 22 science curriculum of public AND NONPUBLIC schools that are
- 23 partnership members.
- 24 (4) Demonstrate how the partnership will provide
- additional professional development opportunities to
- educators employed by public AND NONPUBLIC schools that are
- 27 partnership members.
- 28 (5) Have adopted a proposed budget describing the
- 29 scientific and technical equipment that will be purchased or
- 30 leased with grant funds.

- 1 (d) Grant awards.--The department shall award grants in
- 2 amounts not to exceed \$400,000 for each qualified applicant
- 3 higher education institution. Grants shall be used for the
- 4 purchase or lease of scientific or technical equipment and for
- 5 the development of programs of instruction for members of a
- 6 partnership.
- 7 Section 4. Science technology partnerships.
- 8 (a) Establishment.--A higher education institution may form
- 9 a partnership with three or more public AND NONPUBLIC schools or <
- 10 school districts.
- 11 (b) Partnership agreement. -- The higher education institution
- 12 and the public schools, NONPUBLIC SCHOOLS or school districts
- 13 shall enter into a written agreement defining the
- 14 responsibilities of the partnership members. The agreement shall
- 15 include all of the following:
- 16 (1) The responsibilities of the higher education
- institution in providing services to each partnership member.

- 18 (2) The responsibilities of the public schools,
- 19 NONPUBLIC SCHOOLS or school districts in coordinating with
- 20 the higher education institution.
- 21 (3) A description of the scientific or technical
- 22 equipment that shall be provided to each partnership member.
- 23 (4) A description of the program of instruction that
- will be provided to each partnership member by the higher
- 25 education institution.
- 26 (5) The courses of science instruction and grade levels
- 27 that will be augmented by scientific or technical equipment
- 28 through the partnership and how scientific or technical
- 29 equipment will be used to augment such courses of
- 30 instruction.

- 1 (6) The manner in which access to scientific or
- 2 technical equipment will be provided to students and
- 3 teachers.
- 4 (7) The professional development activities that will be
- 5 provided to science teachers employed by partnership members.
- 6 (c) Forward to department.--To be eligible to participate in
- 7 the program, a partnership must forward a certified copy of its
- 8 partnership agreement to the department.
- 9 Section 5. Powers and duties of department.
- 10 The department shall promulgate rules, regulations and
- 11 procedures necessary to implement the program.
- 12 Section 6. Annual report.
- 13 The secretary shall annually submit a report on the program
- 14 to the Governor, the chairman and minority chairman of the
- 15 Education Committee of the Senate and the chairman and minority
- 16 chairman of the Education Committee of the House of
- 17 Representatives. The report shall include all of the following
- 18 information:
- 19 (1) A description of the types of the partnerships
- 20 created.
- 21 (2) The number of higher education institutions, public

- 22 schools, NONPUBLIC SCHOOLS and public school districts
- 23 participating in the program as members of the partnerships.
- 24 (3) The number of public AND NONPUBLIC school students
- 25 participating in the program.
- 26 (4) The dollar amount of grants awarded to each higher
- 27 education institution and a summary of the institution's
- 28 expenditures on services related to the partnership.
- 29 (5) An assessment of the impact of the program on the
- 30 scientific knowledge of students participating in the

- 1 program.
- 2 Section 7. Effective date.
- 3 This act shall take effect immediately.
