## AN ACT

1 2 3 4 5 6 7 8 9 10 11 12	Amending the act of May 17, 1921 (P.L.682, No.284), entitled "An act relating to insurance; amending, revising, and consolidating the law providing for the incorporation of insurance companies, and the regulation, supervision, and protection of home and foreign insurance companies, Lloyds associations, reciprocal and inter-insurance exchanges, and fire insurance rating bureaus, and the regulation and supervision of insurance carried by such companies, associations, and exchanges, including insurance carried by the State Workmen's Insurance Fund; providing penalties; and repealing existing laws," requiring benefits for physician assistant services.
13	The General Assembly of the Commonwealth of Pennsylvania
14	hereby enacts as follows:
15	Section 1. The act of May 17, 1921 (P.L.682, No.284), known
16	as The Insurance Company Law of 1921, is amended by adding a
17	section to read:
18	Section 635.2. Benefits for Physician Assistant Services
19	(a) As used in this section:
20	(1) "Commissioner" means the Insurance Commissioner of the
21	Commonwealth.
22	(2) "Physician assistant" has the meaning given in section 2

1	of the act of December 20, 1985 (P.L.457, No.112), known as the
2	"Medical Practice Act of 1985."
3	(3) "Physician assistant services" means the general and
4	usual services rendered and care administered by a physician
5	assistant.
6	(b) This section applies to the following:
7	(1) Each group health or sickness insurance policy providing
8	hospital or medical/surgical coverage.
9	(2) Each group accident insurance policy providing hospital
10	or medical/surgical coverage.
11	(3) Each group subscriber contract or certificate providing
12	hospital or medical/surgical coverage issued by an entity
13	subject to any of the following:
14	(i) this act;
15	(ii) 40 Pa.C.S. Ch. 61 (relating to hospital plan
16	corporations) or 63 (relating to professional health services
17	plan corporations); or
18	(iii) the act of December 29, 1972 (P.L.1701, No.364), known
19	as the "Health Maintenance Organization Act."
20	(c) Except as set forth in subsection (e), a policy,
21	contract or certificate specified in subsection (b) shall, in
22	addition to other provisions required by this act, include
23	within the coverage benefits for physician assistant services.
24	(d) The benefits specified in subsection (c) may be provided
25	through any of the following:
26	(1) A combination of policies, contracts or certificates.
27	(2) A prospective payment plan.
28	(e) Subsection (c) shall not apply to any of the following:
29	(1) A Medicare or Medicaid supplemental contract.
30	(2) A limited coverage accident and sickness policy. This

clause includes cancer insurance, polio insurance and dental 1 2 care and any similar policy identified as exempt from this 3 section by the commissioner. (f) Nothing in this section shall serve to diminish the 4 5 benefits of any insured or subscriber in effect on the effective date of this section nor to prevent the offering or acceptance 6 of benefits which exceed the minimum benefits required by this 7 8 section. Section 2. The addition of section 635.2 of the act shall 9 apply to policies, contracts or certificates issued or renewed 10 on or after the effective date of this section. 11

12 Section 3. This act shall take effect in 60 days.
