| 13 | (a) Conveyance from the Commonwealth The Department of |
| 14 | General Services, with the approval of the Governor and the |
| 15 | Department of Conservation and Natural Resources, is hereby |
| 16 | authorized and directed on behalf of the Commonwealth of |
| 17 | Pennsylvania to grant and convey to Anthony R. Domiano, Sr., and |
| 18 | Anthony R. Domiano, Jr., the following tract of land bounded and |

- 10 REMAIN IN THE DEEDS FOR THE LAND DESCRIBED IN SUBSECTION (C):
- 11 "THIS INDENTURE IS GIVEN TO PROVIDE LAND FOR RECREATION,
- 12 CONSERVATION AND HISTORICAL PURPOSES, AS SAID PURPOSES ARE
- 13 DEFINED IN THE 'PROJECT 70 LAND ACQUISITION AND BORROWING ACT,'
- 14 APPROVED JUNE 22, 1964, P.L.131."
- 15 (E) FUNDS.--THE \$190,500 CONSIDERATION FROM THE SALE OF THE
- 16 LAND SHALL BE DEPOSITED IN A SPECIAL ACCOUNT ESTABLISHED BY
- 17 FAYETTE COUNTY FOR ACQUISITION OR DEVELOPMENT OF PARKLAND. USE
- 18 OF FUNDS FROM THE SPECIAL ACCOUNT MUST BE APPROVED IN ACCORDANCE
- 19 WITH A PLAN APPROVED BY THE DEPARTMENT OF CONSERVATION AND
- 20 NATURAL RESOURCES. ANY FUNDS REMAINING IN THE SPECIAL ACCOUNT
- 21 AFTER FIVE YEARS OF THE EFFECTIVE DATE OF THIS ACT SHALL BE PAID
