AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act Relating to the public school system, including certain
- 3 provisions applicable as well to private and parochial
- 4 schools; amending, revising, consolidating and changing the
- 5 laws relating thereto, " further providing for display of
- 6 United States Flag and development of patriotism.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 771(c) of the act of March 10, 1949
- 10 (P.L.30, No.14), known as the Public School Code of 1949,
- 11 amended December 9, 2002 (P.L.1334, No.157), is amended to read:
- 12 Section 771. Display of United States Flag; Development of
- 13 Patriotism.--* * *

- 1 (c) (1) All supervising officers and teachers in charge of
- 2 public[, private or parochial] schools shall cause the Flag of
- 3 the United States of America to be displayed in every classroom
- 4 during the hours of each school day and shall provide for the
- 5 recitation of the Pledge of Allegiance or the national anthem \underline{IN} <--

- 6 <u>EACH CLASSROOM</u> at the beginning of each school day. [Students] <
- 7 UNDER NO CIRCUMSTANCES MAY ANY TEACHER, SCHOOL ADMINISTRATOR,
- 8 BOARD OF SCHOOL DIRECTORS OR OTHER PERSON WAIVE THE REQUIREMENTS
- 9 OF THIS PARAGRAPH. HOWEVER, STUDENTS may decline to recite the
- 10 Pledge of Allegiance and may refrain from saluting the flag on
- 11 the basis of religious conviction or personal belief. [The
- 12 supervising officer of a school subject to the requirements of
- 13 this subsection shall provide written notification to the
- 14 parents or guardian of any student who declines to recite the
- 15 Pledge of Allegiance or who refrains from saluting the flag.
- 16 (2) This subsection shall not apply to any private or
- 17 parochial school for which the display of the flag, the
- 18 recitation of the Pledge of Allegiance or the salute of the flag
- 19 violates the religious conviction on which the school is based.]
- 20 <u>(3) The supervising officer of each public school shall</u>
- 21 <u>include</u>, in any report of grade proficiency provided to the
- 22 parent or quardian of any student, the following:
- 23 <u>(i) information indicating a student's participation in, or</u>
- 24 abstention from, the activities specified in paragraph (1); and
- 25 (ii) other information concerning the student's
- 26 <u>participation in civics education.</u>
- 27 * * *
- 28 Section 2. The provisions of this act are severable. If any
- 29 provision of this act or its application to any person or
- 30 circumstance is held invalid, the invalidity shall not affect

- 1 other provisions or applications of this act which can be given
- 2 effect without the invalid provision or application.
- 3 Section 3. This act shall take effect as follows:
- 4 (1) The addition of section 771(c)(3) of the act shall
- 5 take effect August 1, 2005.
- (2) The remainder of this act shall take effect 6
- 7 immediately.
- 8 SECTION 2. THIS ACT SHALL TAKE EFFECT IMMEDIATELY.
