- 5 WHEREAS, Credit unions employ 8,227 people throughout this
- 6 Commonwealth; and
- WHEREAS, Pennsylvania has 682 credit unions, with 3.4 million
- 8 members and approximately \$22 billion in assets and with 60% of
- 9 Pennsylvania credit unions having assets totaling under \$10
- 10 million; and
- 11 WHEREAS, Credit unions serve an important role in our

- 2 members; and
- 3 WHEREAS, Credit unions encourage and sponsor activities to
- 4 promote the charitable acts of their members; and
- 5 WHEREAS, The unselfish efforts of volunteers organized
- 6 through credit unions have benefited many worthwhile causes in
- 7 this Commonwealth and beyond; therefore be it
