AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An 2 act relating to the public school system, including certain provisions applicable as well to private and parochial 4 schools; amending, revising, consolidating and changing the laws relating thereto, "further providing for powers and duties of the intermediate unit board of directors; and 6 providing for academic improvement programs. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 914-A of the act of March 10, 1949
- (P.L.30, No.14), known as the Public School Code of 1949, is 11
- 12 amended by adding a clause to read:
- Section 914-A. Powers and Duties of the Intermediate Unit 13
- 14 Board of Directors. -- An intermediate unit board of directors
- 15 shall have the power and its duty shall be:
- 16
- 17 (18) To appoint academic improvement teams and coordinate
- and administer the academic improvement program established 18
- under section 925-A. 19
- 20 Section 2. The act is amended by adding a section to read:

- 1 <u>Section 925-A. Academic Improvement Program.--(a) Each</u>
- 2 <u>intermediate unit shall coordinate and administer an academic</u>
- 3 improvement program for any school district assigned to the
- 4 <u>intermediate unit that is eligible for assistance under</u>
- 5 <u>subsection (b)</u>. The intermediate unit shall provide technical
- 6 support and staff assistance to an academic improvement team
- 7 appointed under subsection (c).
- 8 (b) A school district shall be eligible for academic
- 9 assistance under this section where:
- 10 (1) Any school in the school district has a percentage of
- 11 <u>its students in any grade level subject to the Pennsylvania</u>
- 12 System of School Assessment or any other test established by the
- 13 State Board of Education to meet the requirements of section
- 14 <u>2603-B(d)(10)</u> that score below the yearly proficiency target
- 15 <u>established by the Department of Education to calculate adequate</u>
- 16 yearly progress under the No Child Left Behind Act of 2001
- 17 (Public Law 107-110, 115 Stat. 1425).
- 18 (2) Any school in the school district is identified for
- 19 improvement or corrective action under section 1116(c)(3) or
- 20 (10) of the No Child Left Behind Act of 2001.
- 21 (3) The school district requests academic assistance under
- 22 this section.
- 23 (c) (1) Within thirty (30) days of the intermediate unit's
- 24 receipt of the list of school districts eligible under
- 25 subsection (b), an academic improvement team shall be appointed
- 26 for each eligible school district. Members of the academic
- 27 improvement team shall be appointed by the intermediate unit
- 28 board of directors and the board of school directors of the
- 29 school district eligible for academic assistance.
- 30 (2) Five (5) members of the academic improvement team shall

- 1 be appointed by the intermediate unit board of directors. Such
- 2 members shall not be employed by or otherwise affiliated with
- 3 the school district eligible for academic assistance and may
- 4 <u>include:</u>
- 5 (i) Intermediate unit staff members.
- 6 (ii) Teachers.
- 7 <u>(iii) Administrators.</u>
- 8 (iv) School board members.
- 9 (v) Faculty members of colleges or universities in this
- 10 <u>Commonwealth with particular expertise in school improvement.</u>
- 11 (3) Four (4) members of the academic improvement team shall
- 12 <u>be appointed by the board of school directors of the school</u>
- 13 <u>district eligible for academic assistance. Such members shall</u>
- 14 include:
- (i) A parent of a student enrolled in the school district.
- 16 (ii) A teacher employed by the school district.
- 17 (iii) An administrator employed by the school district.
- 18 (iv) A member of the board of school directors of the school
- 19 district.
- 20 (4) The intermediate unit board of directors shall select a
- 21 <u>chairman of the academic improvement team from the members</u>
- 22 appointed under paragraph (2).
- 23 (d) The academic improvement team shall have the following
- 24 powers and duties:
- 25 (1) To create an academic improvement plan pursuant to
- 26 <u>subsection (e) for any school in the school district that is</u>
- 27 eligible for academic assistance under subsection (b)(1) or (2).
- 28 (2) To have ongoing access to school district personnel and
- 29 information related to the academic performance of students.
- 30 (3) To provide periodic reports on the implementation of the

- 1 academic improvement plan to the intermediate unit board of
- 2 directors and the board of school directors of the school
- 3 <u>district eliqible for academic assistance.</u>
- 4 (4) To meet not less than once each month to review the
- 5 implementation of the academic improvement plan.
- 6 (5) To seek technical assistance from the Department of
- 7 Education in the design and implementation of the academic
- 8 improvement plan.
- 9 (e) (1) Within thirty (30) days of the appointment of an
- 10 academic improvement team under subsection (c), the academic
- 11 <u>improvement team shall present an academic improvement plan or</u>
- 12 plans to the intermediate unit board of directors and the board
- 13 of school directors of the school district for approval at a
- 14 public meeting.
- 15 (2) The academic improvement plan or plans shall set forth
- 16 specific goals for improving the academic performance of
- 17 students in content areas subject to the Pennsylvania System of
- 18 School Assessment or any other test established by the State
- 19 Board of Education to meet the requirements of section 2603-
- 20 B(d)(10)(i) and shall include strategies designed to achieve
- 21 those goals. Such strategies shall include, but may not be
- 22 limited to:
- 23 (i) The involvement of parents in the improvement of
- 24 <u>academic performance through the development of home activities</u>
- 25 <u>and materials to enhance student learning.</u>
- 26 (ii) Continuing professional education options in addition
- 27 to options included in the continuing professional education
- 28 plan required under section 1205.1(c.1). Such additional options
- 29 shall be specific to improvements in the academic performance of
- 30 students.

- 1 (iii) Classroom instructional strategies specific to
- 2 <u>improvements in the academic performance of students.</u>
- 3 (iv) The redesign of curricula specific to improvements in
- 4 the academic performance of students.
- 5 (v) Improvements in school safety.
- 6 (vi) Tutoring programs for students whose results on the
- 7 Pennsylvania System of School Assessment or any other test were
- 8 below the level of proficiency established by the State Board of
- 9 Education to meet the requirements of section 2603-B(d)(10)(i).
- 10 (3) The academic improvement plan shall be effective for one
- 11 (1) school year. At the conclusion of the school year and within
- 12 fifteen (15) days of the school district's notification of the
- 13 results of the school district's performance on the Pennsylvania
- 14 System of School Assessment or any other test established by the
- 15 State Board of Education to meet the requirements of section
- 16 <u>2603-B(d)(10)(i)</u>, the academic improvement team shall review
- 17 <u>such results and make a report to the intermediate unit board of</u>
- 18 directors and the board of school directors of the school
- 19 <u>district eliqible for academic assistance.</u>
- 20 (4) Where the school district continues to be eligible for
- 21 academic assistance under subsection (b), the academic
- 22 improvement team shall propose any necessary adjustments to the
- 23 academic improvement plan or plans to the intermediate unit
- 24 board of directors and the board of school directors of the
- 25 school district eligible for academic assistance. Such
- 26 <u>adjustments shall be subject to the approval of the intermediate</u>
- 27 unit board of directors and the board of school directors and
- 28 <u>shall constitute a new academic improvement plan.</u>
- 29 <u>(5) Where the school district is no longer eligible for</u>
- 30 <u>academic assistance under subsection (b), the academic</u>

- 1 improvement team shall recommend the termination of the academic
- 2 improvement plan. Termination of the academic improvement plan
- 3 shall be subject to the approval of the board of school
- 4 directors of the school district eliqible for academic
- 5 assistance.
- 6 (f) The Department of Education shall:
- 7 (1) Annually provide each intermediate unit with a list of
- 8 school districts eligible for academic assistance under
- 9 <u>subsection (b)(i) or (ii).</u>
- 10 (2) Upon request, provide technical assistance to an
- 11 <u>academic improvement team.</u>
- 12 (3) Establish a clearinghouse of information related to
- 13 strategies for improving the academic performance of students
- 14 under subsection (e)(2).
- 15 (4) Establish and provide continuing professional education
- 16 courses, programs, activities or learning experiences under
- 17 <u>section 1205.2(f)</u> <u>specific to the classroom strategies to</u>
- 18 improve the academic performance of students in content areas
- 19 subject to the Pennsylvania System of School Assessment or any
- 20 other test established by the State Board of Education to meet
- 21 the requirements of section 2603-B(d)(10)(i).
- 22 Section 3. Section 2595 of the act is amended by adding a
- 23 subsection to read:
- 24 Section 2595. School Performance Incentives. -- * * *
- 25 (f.3) No less than fifty percent (50%) of the allocation for
- 26 <u>school performance funding under this section shall be used by</u>
- 27 the Department of Education to establish an incentive program to
- 28 reward school districts eligible for academic assistance under
- 29 section 925-A that show improved academic performance as
- 30 evidenced by a decline in the percentage of students scoring

- below the level of proficiency on the Pennsylvania System of 1
- 2 <u>School Assessment or any other test established by the State</u>
- 3 Board of Education to meet the requirements of section 2603-
- $4 \quad B(d)(10)(i)$.

- 6 Section 4. This act shall take effect in 60 days.
