1 Amending Title 34 (Game) of the Pennsylvania Consolidated
2 Statutes, further providing for resident license and fee
3 exemptions AND FOR LICENSE COSTS AND FEES. <—

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Section 2706 of Title 34 of the Pennsylvania
7 Consolidated Statutes is amended by adding a subsection to read:
8 § 2706. Resident license and fee exemptions.

9 * * *

10 (b.1) Prisoners of war.--A former prisoner of war shall be
11 entitled to purchase a resident hunting license at the cost of
12 \$1 upon application to the commission. An application under this
13 subsection shall contain the same information as is required for
14 other resident hunting license applications. As used in this

1 subsection, the term "former prisoner of war" means an
2 individual who was imprisoned by enemy forces while in the
3 service of the armed forces of the United States as certified by
4 the appropriate branch of the armed forces of the United States.

9 § 2709. LICENSE COSTS AND FEES.

10 (A) LICENSE COSTS.--ANY PERSON WHO QUALIFIES UNDER THE
11 PROVISIONS OF THIS CHAPTER SHALL BE ISSUED THE APPLICABLE
12 LICENSE UPON PAYMENT OF THE FOLLOWING COSTS AND THE ISSUING
13 AGENT'S FEE:

15 (2) (I) ADULT RESIDENT HUNTING - \$19.

16 (II) RESIDENT MILITARY PERSONNEL HUNTING - \$1.

17 (III) FORMER PRISONER OF WAR HUNTING - \$1.
