## AN ACT

- 1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
- act relating to the public school system, including certain
- provisions applicable as well to private and parochial
- 4 schools; amending, revising, consolidating and changing the
- laws relating thereto," further providing for program of
- 6 continuing professional development.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 1205.2(f) of the act of March 10, 1949
- 10 (P.L.30, No.14), known as the Public School Code of 1949, added
- 11 November 23, 1999 (P.L.529, No.48), is amended and the section
- 12 is amended by adding a subsection to read:
- 13 Section 1205.2. Program of Continuing Professional
- 14 Education.--\* \* \*

- 1 (f) The department shall annually provide a minimum of forty
- 2 (40) hours of continuing professional education courses,
- 3 programs, activities or learning experiences at no charge to
- 4 professional educators [employed by a school entity]. In
- 5 providing these courses, the department shall seek to use the
- 6 most efficient and cost-effective means possible, including the
- 7 use of advanced technology such as CD-ROM, the Internet and
- 8 distance communication.
- 9 \* \* \*
- 10 (k.1) (1) Notwithstanding the provisions of subsections (a)
- 11 and (k), the certificate of a professional educator who is an
- 12 <u>annuitant as defined in 24 Pa.C.S. § 8102 (relating to</u>
- 13 <u>definitions</u>) or 71 Pa.C.S. § 5102 (relating to definitions)
- 14 shall be considered active for so long as the professional
- 15 <u>educator is an annuitant, except as otherwise provided in this</u>
- 16 subsection.
- 17 (2) For a professional educator annuitant who terminates the
- 18 annuity or returns to school service under the provisions of 24
- 19 Pa.C.S. § 8346(b) (relating to termination of annuities) or
- 20 whose annuity ceases under the provisions of 24 Pa.C.S. §
- 21 8346(b), the requirements of subsection (a) shall not apply for
- 22 the first one hundred eighty (180) days for which the
- 23 professional educator annuitant returns to school service.
- 24 (3) A professional educator annuitant who has returned to
- 25 <u>school service and who continues in school service for more than</u>
- 26 one hundred eighty (180) days shall fulfill the requirements of
- 27 subsection (a) beginning with the one hundred eighty-first day
- 28 for which the professional educator has returned to school
- 29 <u>service</u>. Such professional educator shall have the same number
- 30 of hours of continuing professional education and the same

- 1 amount of time to complete those hours as existed for the
- 2 professional educator at the time the professional educator
- 3 became an annuitant: Provided, that any collegiate studies,
- 4 continuing professional education courses, or other programs,
- 5 <u>activities or learning experiences completed by a professional</u>
- 6 educator annuitant during the one hundred eighty (180) days for
- 7 which the requirements of subsection (a) are not applicable
- 8 under paragraph (2) shall be added to the number of hours of
- 9 continuing professional education the professional educator had
- 10 at the time the professional educator became an annuitant.
- 11 (4) The department shall promulgate a standard pursuant to
- 12 the act of June 25, 1982 (P.L.633, No.181), known as the
- 13 "Regulatory Review Act," requiring school entities to report the
- 14 employment of professional educator annuitants subject to 24
- 15 Pa.C.S. § 8346(b) and this subsection.
- 16 (5) The Public School Employees' Retirement System
- 17 established pursuant to 24 Pa.C.S. Pt. IV (relating to
- 18 retirement for school employees) shall adopt quidelines
- 19 requiring school entities to report the employment under this
- 20 subsection of annuitants subject to 24 Pa.C.S. § 8346(b).

- 22 Section 2. This act shall take effect in 60 days.
