AN ACT

- Amending the act of June 29, 1953 (P.L.304, No.66), entitled "An 2 act providing for the administration of a statewide system of vital statistics; prescribing the functions of the State 3 4 Department of Health, the State Advisory Health Board and local registrars; imposing duties upon coroners, 6 prothonotaries, clerks of orphans' court, physicians, 7 midwives and other persons; requiring reports and 8 certificates for the registration of vital statistics; 9 regulating the disposition of dead bodies; limiting the 10 disclosure of records; prescribing the sufficiency of vital 11 statistics records as evidence; prescribing fees and 12 penalties; and revising and consolidating the laws relating 13 thereto, " further providing for reports to county 14 registration commissions.
- 15 The General Assembly of the Commonwealth of Pennsylvania
- 16 hereby enacts as follows:
- 17 Section 1. Section 801.1 of the act of June 29, 1953
- 18 (P.L.304, No.66), known as the Vital Statistics Law of 1953,
- 19 amended November 23, 2004 (P.L.909, No.122), is amended to read:
- 20 Section 801.1. Records: Reports to County Registration

- 1 Commissions. -- The department shall, within 30 days of the last
- 2 <u>day of each calendar month</u>, report [monthly] in writing to the
- 3 registration commission of each county the deaths of residents
- 4 of such counties, except residents less than eighteen years of
- 5 age, for [the preceding] that month. Said report shall contain
- 6 the full name of the decedent, his or her last address, the date
- 7 of his or her birth if available, and the date of his or her
- 8 death. A copy of each report shall be filed contemporaneously
- 9 with the Bureau of Commissions, Elections and Legislation in the
- 10 <u>Department of State</u>.
- 11 Section 2. This act shall take effect in 60 days.
