- 10 (f) Active duty members. Any active duty member of the
- Pennsylvania National Guard who shall apply for an adult 11
- resident hunting or adult resident furtaking license shall be 12
- 13 exempt from the fees provided in section 2709(a)(2)(i) and (13)

1	(relating to license costs and fees), for a period not to exceed
2	one year after discharge from active duty. Upon proof that the
3	member meets the qualifications of section 2701 (relating to
4	<u>license requirements) and documentation showing the dates of</u>
5	active duty, the commission or county treasurer shall issue a
6	hunting or furtaking license.
7	(F) PENNSYLVANIA NATIONAL GUARD HUNTING LICENSES
8	(1) PENNSYLVANIA NATIONAL GUARD HUNTING LICENSES SHALL
9	BE ISSUED BY THE COMMISSION OR COUNTY TREASURER TO PERSONS
10	WHO ARE MEMBERS OF THE PENNSYLVANIA NATIONAL GUARD AND WHO
11	SATISFY ALL OF THE FOLLOWING REQUIREMENTS:
12	(I) HAVE BEEN ORDERED TO ACTIVE FEDERAL SERVICE AND
13	DEPLOYED OVERSEAS FOR A PERIOD OF 180 CONSECUTIVE DAYS OR
14	MORE, INCLUDING MEMBERS RELEASED EARLY FROM SUCH SERVICE
15	BECAUSE OF AN INJURY OR DISEASE INCURRED IN LINE OF DUTY.
16	(II) HAVE PRESENTED DOCUMENTATION SHOWING THE DATES
17	OF ACTIVE FEDERAL SERVICE AND DEPLOYMENT.
18	(2) A MEMBER OF THE PENNSYLVANIA NATIONAL GUARD ELIGIBLE
19	FOR A PENNSYLVANIA NATIONAL GUARD HUNTING LICENSE UNDER THIS
20	SUBSECTION MAY APPLY FOR AND RECEIVE ONE SUCH LICENSE FOR ANY
21	LICENSE YEAR BEGINNING ON THE DATE OF THE MEMBER'S RELEASE
22	FROM ACTIVE FEDERAL SERVICE AND ENDING 24 MONTHS THEREAFTER.
23	(3) A MEMBER WHO IS ELIGIBLE FOR A PENNSYLVANIA NATIONAL
24	GUARD HUNTING LICENSE UNDER THIS SUBSECTION SHALL BE ISSUED
25	ONLY ONE SUCH ANNUAL LICENSE PER QUALIFYING DEPLOYMENT.
26	(4) THE COMMISSION MAY PROMULGATE REGULATIONS TO
27	IMPLEMENT THIS SUBSECTION.
