1 2 3 4	Amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, providing for deferral of Pennsylvania Higher Education Assistance Agency loan payments for certain Pennsylvania National Guard members.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Title 51 of the Pennsylvania Consolidated
8	Statutes is amended by adding a section to read:
9	§ 3106. Deferred PHEAA loan payments.
10	(a) ApplicabilityThis section shall apply to members of
11	<u>the Pennsylvania National Guard who are called or ordered to</u>
12	active duty with the armed forces of the United States, other

13 than active duty for training, or to State active duty under

1	this title, and members of other reserve components who are
2	called or ordered to active duty with the armed forces of the
3	<u>United States, other than active duty for training, when the</u>
4	period of active duty or State active duty is 30 consecutive
5	days or more.
6	(b) Deferral of paymentsA member of the Pennsylvania
7	National Guard or other reserve component of the armed forces of
8	the United States, as described in subsection (a), may defer
9	without cost, penalty or accrual of interest any educational
10	loan payments due to the Pennsylvania Higher Education
11	Assistance Agency during the period of active duty described in
12	subsection (a).
13	(c) Grace periodA member of the Pennsylvania National
14	Guard or other reserve component of the armed forces of the
15	United States, as described in subsection (a), may defer without
16	cost, penalty or accrual of interest any educational loan
17	payment due or that may be due to the Pennsylvania Higher
18	Education Assistance Agency for a period of six months
19	immediately following the period of active duty described in
20	subsection (a). To qualify under this section, the member shall
21	provide documentation showing the dates of active duty to the
22	Pennsylvania Higher Education Assistance Agency.
23	Section 2. This act shall take effect in 60 days.
