## AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, prohibiting tobacco possession and use
- 3 by minors.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 6306.1(a), (b) and (d) of Title 18 of
- 7 the Pennsylvania Consolidated Statutes are amended to read:
- 8 § 6306.1. Use or possession of tobacco [in schools] by minors
- 9 prohibited.
- 10 (a) Offense defined.--A [pupil] minor under 18 years of age
- 11 who possesses or uses tobacco [in a school building, a school
- 12 bus or on school property owned by, leased by or under the
- 13 control of a school district] commits a summary offense.
- 14 (b) Grading.--A [pupil] minor who commits an offense under
- 15 this section [shall be subject to prosecution initiated by the
- 16 local school district and] shall, upon conviction, be sentenced
- 17 to pay a fine of not more than [\$50 for the benefit of the
- 18 school district in which such offending pupil resides] \$100 and

- 1 to pay court costs. [When a pupil is charged with violating
- 2 subsection (a), the] The court may admit the offender to an
- 3 adjudication alternative as authorized under 42 Pa.C.S. § 1520
- 4 (relating to adjudication alternative program) in lieu of
- 5 imposing the fine.

- 7 (d) Definitions.--As used in this section, the [following
- 8 words and phrases shall have the meanings given to them in this
- 9 subsection:
- 10 "Pupil." A person between the ages of 6 and 21 years who is
- 11 enrolled in school.
- "School." A school operated by a joint board, board of
- 13 directors or school board where pupils are enrolled in
- 14 compliance with Article XIII of the act of March 10, 1949
- 15 (P.L.30, No.14), known as the Public School Code of 1949,
- 16 including area vocational schools and intermediate units.
- 17 "Tobacco." A] term "tobacco" means a lighted or unlighted
- 18 cigarette, cigar, pipe or other lighted smoking product and
- 19 smokeless tobacco in any form.
- 20 Section 2. This act shall take effect in 60 days.
