- 6 Section 1. Section 2702 of Title 30 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a subsection to read:
- 8 § 2702. Nonresident and tourist licenses.

- 10 (d) One-day tourist licenses.--Any person required to have a
- 11 fishing license under this chapter may fish in any of the waters
- 12 of this Commonwealth or in any boundary waters for a period not
- 13 to exceed 24 hours, specified by the person at time of purchase,
- 14 with a "One-Day Tourist Fishing License" upon payment of a

- 1 license fee and issuing agent fee as set forth in section 2715.
- 2 One-Day Tourist Fishing Licenses shall not be issued for fishing
- 3 during the period from April 1 to April 30 of any year. Holders
- 4 of One-Day Tourist Fishing Licenses shall not be required to
- 5 obtain special permits, including trout/salmon permits to fish
- 6 for trout or salmon or special permits to fish in Lake Erie and
- 7 tributaries.

- 13 § 2702.1. One-day <u>resident</u> fishing license.
- 14 (a) General rule. -- A person required to have a fishing
- 15 license under section 2701 (relating to resident fishing
- 16 licenses) may fish in any waters of this Commonwealth or in any
- 17 boundary waters for a period not to exceed [one calendar day
- 18 (12:01 a.m. to midnight)] 24 hours, specified by the person at
- 19 <u>time of purchase</u>, with a One-Day <u>Resident</u> Fishing License upon
- 20 payment of a license fee and issuing agent fee set forth in
- 21 section 2715 (relating to license, permit and issuing agent
- 22 fees).
- 23 (b) Limitation on issue.--One-Day <u>Resident</u> Fishing Licenses
- 24 shall not be issued for fishing during the period from April 1
- 25 to April 30 of any year.
- 26 (c) Additional stamps and permits required.--Holders of One-
- 27 Day Resident Fishing Licenses shall obtain all required special
- 28 permits, including trout/salmon permits to fish for trout or
- 29 salmon and special permits to fish in Lake Erie and tributaries.

- 6 (3) Senior Resident Lifetime Fishing License, \$50.
- 7 (4) Nonresident Annual Fishing License, \$51.
- 8 (5) Seven-Day Tourist Fishing License, \$33.
- 9 (6) Three-Day Tourist Fishing License, \$25.
- 10 (6.1) One-Day <u>Resident</u> Fishing License, \$10.
- 11 (6.2) One-Day Tourist Fishing License, \$25.
- 12 (7) Replacement Fishing License, \$4.25.
