AN ACT

Authorizing and directing the Department of General Services, with the approval of the Governor, to convey tracts of land 3 and buildings, consisting of a portion of the former Laurelton Center, located in Hartley Township, Union County, 5 Pennsylvania; AND MAKING A RELATED REPEAL. 6 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 8 Section 1. The Department of General Services, with the SECTION 1. - 18 or pipeline companies, as well as under the subject to any
- 19 interest, estates or tenancies vested in third persons, whether

- 22 Section 3. No portion of the property shall be used for
- 23 gaming or gambling activities. Should the grantee, its
- 24 successors or assigns, utilize the property for gaming or
- 25 gambling or for any other purpose not permitted under this
- 26 paragraph, the property conveyed herein shall immediately revert
- 27 to and revest in the grantor.
- 28 (D) GENERAL LAND USE RESTRICTION. -- THE CONVEYANCE SHALL BE
- 29 UNDER AND SUBJECT TO THE CONDITION, WHICH SHALL BE CONTAINED IN
- 30 THE DEED, THAT NO PORTION OF THE PROPERTY BEING CONVEYED SHALL

- 1 BE USED AS A LICENSED FACILITY, AS THAT TERM IS DEFINED IN 4
- 2 PA.C.S. § 1103 (RELATING TO DEFINITIONS) OR FOR ANY OTHER
- 3 SIMILAR TYPE OF FACILITY AUTHORIZED UNDER STATE LAW. THE
- 4 CONDITION SHALL BE A COVENANT RUNNING WITH THE LAND AND SHALL BE
- 5 BINDING UPON THE GRANTEE, ITS SUCCESSORS AND ASSIGNS. IF A
- 6 GRANTEE, ITS SUCCESSORS OR ASSIGNS PERMIT THE PROPERTY
- 7 AUTHORIZED TO BE CONVEYED IN THIS SECTION, OR ANY PORTION OF THE

- 12 TO THE PROVISIONS OF THE ACT OF JUNE 18, 1982 (P.L.549, NO.159),
- 13 ENTITLED, "AN ACT PROVIDING FOR THE ADMINISTRATION OF CERTAIN
- 14 COMMONWEALTH FARMLAND WITHIN THE DEPARTMENT OF AGRICULTURE,"
- 15 SHALL CONTINUE TO BE SUBJECT TO THE RESTRICTIONS PROVIDED FOR IN
- 16 THAT ACT AND A RESTRICTIVE COVENANT LIMITING THE USES OF THE

- GOVERNOR, TO GRANT AND CONVEY TO THE CITY OF MCKEESPORT A TRACT 12
- 13 OF LAND SITUATE IN THE SEVENTH WARD, CITY OF MCKEESPORT,
- 14 ALLEGHENY COUNTY, AND TO SELL AND CONVEY TO SMITHFIELD TOWNSHIP
