## AN ACT

- 1 Providing for a Statewide Child Day-Care Resource and Referral
- 2 System; and imposing additional responsibilities upon the
- 3 Department of Public Welfare.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Child Day-
- 8 Care Resource and Referral Act.
- 9 Section 2. Legislative findings.
- 10 The General Assembly finds and declares as follows:
- 11 (1) The demand for high quality, affordable, accessible
- 12 child day care has increased dramatically in the last decade
- in correlation with a dramatic increase in the labor force
- 14 participation rate of parents with young children.
- 15 (2) According to the United States Census, in the decade
- from 1990 to 2000, the rate of families in which all parents

- 1 in the household work rose to 62%, a 10% increase over the
- decade. In this Commonwealth, about two-thirds of mothers
- 3 with children under the age of six are in the work force,
- 4 compared to 25% in 1970.
- 5 (3) There are more than 884,000 children under the age
- of six living in this Commonwealth, and a majority of these
- 7 children spend on average 27 hours a week in some form of
- 8 child day care.
- 9 (4) As of January 2001, close to 300,000 children were
- served in regulated child care settings in this Commonwealth.
- 11 (5) A comprehensive, coordinated effort is needed to
- ensure that accurate, up-to-date child day-care information
- is readily available and easy to access.
- 14 (6) Local child day-care resource and referral services
- 15 are beneficial to:
- (i) working parents of all economic means by
- enabling them to make informed choices in selecting and
- 18 purchasing the child day care that best meets their
- 19 family's unique needs;
- 20 (ii) existing and prospective child day-care
- 21 providers in their efforts to develop and maintain safe,
- 22 high-quality child day-care services;
- 23 (iii) businesses by providing them with information
- to use in responding to child day-care needs of their
- employees; and
- 26 (iv) the community-at-large by contributing directly
- 27 to the health, safety and well-being of this
- 28 Commonwealth's children and their families.
- 29 Section 3. Definitions.
- The following words and phrases when used in this act shall

- 1 have the meanings given to them in this section unless the
- 2 context clearly indicates otherwise:
- 3 "Child day care." Care in lieu of parental care, given for
- 4 part of the 24-hour day to children under 16 years of age, away
- 5 from their own homes. The term does not include child day care
- 6 furnished in places of worship during religious services.
- 7 "Child day-care resource and referral agency." A public or
- 8 private nonprofit entity that performs functions related to
- 9 child day-care resource and referral services. The term includes
- 10 an association or a corporation.
- "Child day-care resource and referral services." The term
- 12 includes the following:
- 13 (1) The provision of updated information to the parents,
- employers and individuals in a community regarding the
- availability, cost and quality of child day-care services in
- 16 a defined geographic area.
- 17 (2) Assistance to parents so they can make informed
- decisions regarding appropriate, affordable child day-care
- 19 services for their children.
- 20 (3) Information to employers on programs designed to
- 21 meet the child day-care needs of employees.
- 22 (4) Provision of start-up information to potential child
- 23 day-care providers to increase the supply of providers.
- 24 "Department." The Department of Public Welfare of the
- 25 Commonwealth.
- 26 Section 4. Resource and referral services.
- 27 The department shall arrange for child day-care resource and
- 28 referral services across this Commonwealth through contracts
- 29 with public or private entities that can fulfill the
- 30 responsibility of a child day-care resource and referral agency,

- 1 which shall provide, at a minimum, the following services:
- 2 (1) Identification of all State-approved child day-care
- 3 providers in their specific geographic area and a profile of
- 4 each provider to indicate the types of services they provide
- 5 and the costs of such services.
- 6 (2) Maintenance of a regularly updated resource file
- 7 that demonstrates supply and demand of services.
- 8 (3) Maintenance of a resource and referral service for
- 9 child day-care users and assistance, if requested, in
- 10 evaluating child day-care needs and appropriateness of types
- of child day care.
- 12 (4) Establishment of a public education program to
- inform consumers and provide referral counseling about child
- 14 day-care options, including information on types of child day
- care, availability, cost and standards, through such means as
- printed materials, telephone contacts, education sessions or
- 17 workshops and resource libraries.
- 18 (5) Provision of information and technical assistance to
- 19 providers and prospective providers, as requested. Types of
- information to be made available shall include, but not be
- limited to, information regarding career opportunities in the
- field, continuing education, training opportunities,
- 23 accreditation programs, regulatory requirements, food
- 24 programs and demographic information to determine the
- 25 existence of markets for services and to help stimulate the
- 26 supply of child day-care services needed in the area.
- 27 (6) Provision of information to employers who are trying
- to meet the child day-care needs of their employees.
- 29 (7) Collection and maintenance of data, as may be useful
- 30 in State and local planning efforts, on the number and usage

- of different child day-care providers, the type, availability
- 2 and cost of child day care in a particular geographic area
- and demographic information to determine whether the supply
- 4 meets the demand for child day-care services in a given area.
- 5 (8) Provision of information to low-income parents about
- 6 child day-care services for which they may be eligible and
- 7 referral to a local entity responsible for administering
- 8 Federal and State child day care funds. The child day-care
- 9 resource and referral agency shall also provide to parents
- 10 receiving public assistance information about child day-care
- services for which they may be eligible, and how they can
- 12 access those funds. The child day-care resource and referral
- agency shall avoid duplicating services and shall develop
- 14 procedures to streamline services for all low-income parents
- 15 needing child day-care services.
- 16 Section 5. Standard operating procedures.
- 17 Child day-care resource and referral agencies shall:
- 18 (1) Conduct business during hours convenient to working
- 19 parents, including some evening and weekend hours, if deemed
- 20 necessary.
- 21 (2) Have the authority to establish a reasonable range
- of fees for services, with the approval of the department.
- 23 (3) Advertise their services. All recipients of services
- shall be informed of applicable fees prior to the provision
- of such services, as designated in this act.
- 26 (4) Tailor services provided for in this act to the
- 27 geographically defined area in which they are located.
- 28 (5) Seek opportunities to provide educational and
- 29 consumer awareness programs.
- 30 (6) Utilize, to the maximum extent, the most cost-

- 1 effective means of providing child day-care resource and
- 2 referral services in accordance with this act, including, but
- 3 not limited to, public-private partnerships, where deemed
- 4 appropriate, and contractual arrangements with existing
- 5 providers of resource and referral services.
- 6 (7) Maintain confidentiality of records. Information
- 7 contained in the records shall not be publicly disclosed in
- 8 such a manner so as to identify individuals. Certain
- 9 nonidentifying information may, however, be collected in
- 10 aggregate form for the purposes of data collection.
- 11 (8) Report to the department on a regular basis
- information regarding:
- 13 (i) The number of parents and children served.
- 14 (ii) The extent of assistance given to providers,
- parents, businesses and others.
- 16 (iii) Fees charged for resource and referral
- services provided for in this act.
- 18 (iv) The impact of the resource and referral
- 19 services on quality and availability of child day care in
- their particular geographically defined area.
- 21 (v) Any recommendations that may contribute to the
- 22 improvement of the provision of child day-care resource
- and referral services.
- 24 Section 6. Annual report.
- 25 The department shall submit an annual report to the General
- 26 Assembly which shall reflect the information collected by the
- 27 child day-care resource and referral agencies designated by the
- 28 department. The report shall describe how the child day-care
- 29 resource and referral agencies further the department's goal to
- 30 improve the quality, availability and affordability of child

- 1 day-care services. This report shall also include any
- 2 recommendations of the department for improvements to the
- 3 Statewide resource and referral system, as well as the
- 4 availability of private, corporate and government funding for
- 5 resource and referral services.
- 6 Section 7. Regulations.
- 7 The department shall, in the manner provided by law,
- 8 promulgate the regulations necessary to establish child day-care
- 9 resource and referral services to be offered in accordance with
- 10 this chapter.
- 11 Section 8. Resource and referral services implementation.
- 12 The department shall establish a three-year implementation
- 13 schedule for phasing in child day-care resource and referral
- 14 services throughout this Commonwealth.
- 15 Section 20. Effective date.
- 16 This act shall take effect July 1, 2005.
