## AN ACT

- 1 Amending the act of July 7, 2005 (P.L. , No.44), entitled,
- 2 "An act amending Titles 42 (Judiciary and Judicial
- 3 Procedure), 46 (Legislature) and 71 (State Government) of the
- 4 Pennsylvania Consolidated Statutes, providing for
- 5 compensation; and making an inconsistent repeal, "further
- 6 providing for applicability.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 4 of the act of July 7, 2005 (P.L.
- 10 No.44), entitled, "An act amending Titles 42 (Judiciary and
- 11 Judicial Procedure), 46 (Legislature) and 71 (State Government)
- 12 of the Pennsylvania Consolidated Statutes, providing for
- 13 compensation; and making an inconsistent repeal," is amended to
- 14 read:
- 15 Section 4. This act shall apply as follows:
- 16 (1) [Except for the application of 46 Pa.C.S. § 1107,

- 1 the addition of 46 Pa.C.S. §§ 1101 through 1104 and 1106(a)]
- 2 The addition of 46 Pa.C.S. Ch. 11 shall apply to members of
- 3 the General Assembly elected after the effective date of this
- 4 act.
- 5 [(2) The addition of 46 Pa.C.S. § 1107 shall apply to
- 6 members of the General Assembly elected prior to the
- 7 effective date of this act.]
- 8 (3) The addition of 71 Pa.C.S. §§ 1102(c) and 1105 shall
- 9 apply to individuals who are appointed after December 31,
- 10 2006.
- 11 (4) The addition of 71 Pa.C.S. §§ 1102(a) and (b) and
- 12 1103 shall apply to individuals who are elected after the
- 13 effective date of this act.
- 14 (5) For purposes of section 3(d) of the act of September
- 15 30, 1983 (P.L.160, No.39), known as the Public Official
- 16 Compensation Law, the salary of the Secretary of Community
- and Economic Development shall be deemed to be the salary on
- 18 the day before the effective date of this act. This salary is
- 19 subject to adjustment under section 3(e) of the Public
- 20 Official Compensation Law.
- 21 Section 2. The amendment of section 2 of the act shall apply
- 22 retroactively to July 7, 2005.
- 23 Section 3. This act shall take effect immediately.
