AN ACT

- Amending the act of June 13, 1907 (P.L.560, No.373), entitled 2 "An act designating the official flag of the Commonwealth of 3 Pennsylvania, and describing the same; providing for the carrying of such flag by the regiments of the National Guard of Pennsylvania; authorizing the Secretary of the 5 Commonwealth to provide, and have deposited in the office of 6 7 Secretary of the Commonwealth, a model of said flag, and 8 making an appropriation therefor," further providing for specifications for the official flag of the Commonwealth and 9 for the duties of the Secretary of the Commonwealth. 10
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Sections 1 and 3 of the act of June 13, 1907
- 14 (P.L.560, No.373), entitled "An act designating the official
- 15 flag of the Commonwealth of Pennsylvania, and describing the
- 16 same; providing for the carrying of such flag by the regiments
- 17 of the National Guard of Pennsylvania; authorizing the Secretary
- 18 of the Commonwealth to provide, and have deposited in the office
- 19 of Secretary of the Commonwealth, a model of said flag, and

- 1 making an appropriation therefor, are amended to read:
- 2 Section 1. Be it enacted, &c., That the flag to be known as
- 3 the official flag of the Commonwealth of Pennsylvania shall be
- 4 of blue, same color as the blue field in the flag of the United
- 5 States, and of the following dimensions and design; to wit, The
- 6 length, or heighth, of the staff to be nine feet, including
- 7 brass spear-head and ferrule; the fly of the said flag to be six
- 8 feet two inches, and to be four feet six inches on the staff; in
- 9 the center of the flag there shall be embroidered in silk the
- 10 same on both sides of the flag the coat of arms of the
- 11 Commonwealth of Pennsylvania, in proportionate size; the edges
- 12 to be trimmed with knotted fringe of yellow silk, two and one-
- 13 half inches wide; a cord, with tassels, to be attached to the
- 14 staff at the spear-head, to be eight feet six inches long, and
- 15 composed of white and blue silk strands[.]; the word
- 16 "Pennsylvania" to be embroidered upon the flag in yellow silk
- 17 and to be centered within a symmetrical red festoon, similar to
- 18 that containing the State motto; and the festoon to be centered
- 19 above the bald eagle on the coat of arms. days.
- 20 Section 3. The [Secretary of the Commonwealth is hereby
- 21 directed to provide a] Pennsylvania Historical and Museum
- 22 Commission shall:
- 23 (1) redesign the flag, in accordance with the description
- 24 given in the first section of this act[, and keep the same
- 25 deposited in the office of the Secretary of the Commonwealth, as
- 26 a model; the cost of said flag to be paid by warrant of the
- 27 Auditor General upon the State Treasurer; and for this purpose
- 28 the sum of one hundred and fifty dollars, or so much thereof as
- 29 may be necessary, is hereby specifically appropriated, out of
- 30 any moneys in the State Treasury not otherwise appropriated.]:

- 1 (2) place the original redesigned flag and model thereof in
- 2 the Pennsylvania State Archives, as the official repository of
- 3 the redesigned flag; and
- 4 (3) publish the specifications for and a copy of the
- redesigned flag in the Pennsylvania Bulletin and on the 5
- 6 commission's Internet website.
- Section 2. This act shall take effect in 60 days. 7
