1 {certificate} <u>certification</u> of death of an eligible firefighter, <----2 ambulance service or rescue squad member, law enforcement 3 officer or National Guard member who died as a result of the 4 performance of his or her duties {filed} <u>submitted to the</u> <-----5 Commonwealth under section 1(a) of the act on or after December 15, 2003.] THE AMENDMENT OR ADDITION OF SECTION 1(A.1), (D) AND 6 <-----7 (E) OF THE ACT SHALL APPLY RETROACTIVELY TO INCLUDE ANY 8 CERTIFICATE OF DEATH OF AN ELIGIBLE FIREFIGHTER, AMBULANCE 9 SERVICE OR RESCUE SQUAD MEMBER, LAW ENFORCEMENT OFFICER OR 10 NATIONAL GUARD MEMBER WHO DIED AS A RESULT OF THE PERFORMANCE OF 11 HIS OR HER DUTIES FILED ON OR AFTER DECEMBER 15, 2003, OR WHERE 12 THE CLAIM FOR BENEFITS AS THE RESULT OF A DEATH ON OR AFTER 13 NOVEMBER 15, 2003, HAD NOT BEEN FINALLY ADJUDICATED ON DECEMBER <u>15, 2003.</u> 14

15 Section 2. This act shall take effect immediately.
