AN ACT

- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
- 2 Consolidated Statutes, further providing for immunity from
- 3 liability; and providing for false reports of child abuse or
- 4 neglect.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 6318 of Title 23 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 6318. Immunity from liability.
- 10 (a) General rule. -- A person, hospital, institution, school,
- 11 facility, agency or agency employee that participates in good
- 12 faith in the making of a report, cooperating with an
- 13 investigation, testifying in a proceeding arising out of an
- 14 instance of suspected child abuse, the taking of photographs or
- 15 the removal or keeping of a child pursuant to section 6315
- 16 (relating to taking child into protective custody), and any
- 17 official or employee of a county agency who refers a report of
- 18 suspected abuse to law enforcement authorities or provides

- 1 services under this chapter, shall have immunity from civil and
- 2 criminal liability that might otherwise result by reason of
- 3 those actions except as provided under section 6320 (false
- 4 reports of child abuse).
- 5 (b) Presumption of good faith. -- For the purpose of any civil
- 6 or criminal proceeding, the good faith of a person required to
- 7 report pursuant to section 6311 (relating to persons required to
- 8 report suspected child abuse) and of any person required to make
- 9 a referral to law enforcement officers under this chapter shall
- 10 be presumed and may be rebutted only by clear and convincing
- 11 evidence.
- 12 Section 2. Title 23 is amended by adding a section to read:
- 13 § 6320. False reports of child abuse.
- 14 A person who knowingly or intentionally makes a report of
- 15 <u>child abuse under this chapter that the person knows is false</u>
- 16 <u>commits a misdemeanor</u>.
- 17 Section 3. This act shall take effect in 60 days.
